## 1 Parameter-Dependent Integrals

### 1.1 Introduction to Parameter-Dependent Integral

#### 1.1.1 Definition: Parameter-Dependent Integrals

Let  $a, b, c, d \in \mathbb{R}$  be real numbers and let  $f : [a, b] \times [c, d] \rightarrow \mathbb{R}$  be an integrable scalar function of two variables. The parameter-dependent integral  $F$  is the scalar function  $F : [c, d] \rightarrow \mathbb{R}$  defined by

$$F(t) = \int_a^b f(x, t) \, dx$$

where the variable  $t$  is called the parameter.

#### 1.1.2 Proposition: Continuity of Parameter-Dependent Integrals

Let  $a, b, c, d \in \mathbb{R}$  be real numbers and  $f : [a, b] \times [c, d] \rightarrow \mathbb{R}$  be a continuous function. In this case, the function  $F : [c, d] \rightarrow \mathbb{R}$  defined by

$$F(t) = \int_a^b f(x, t) \, dx$$

is also continuous.

#### 1.1.3 Proposition: Differentiability of Parameter-Dependent Integrals I

Let  $f(x, t) : P = [a, b] \times [c, d] \rightarrow \mathbb{R}$  be a continuous function and continuously differentiable with respect to the second variable (i.e.  $\frac{\partial f}{\partial t}$  is continuous everywhere on  $P$ ). In this case, the function

$$F(t) = \int_a^b f(x, t) \, dx$$

is differentiable on  $[c, d]$  and

$$F'(t) = \int_a^b \frac{\partial f}{\partial t} \, dx$$

#### 1.1.4 Proposition: Differentiability of Parameter-Dependent Integrals II

This proposition extends the previous one to include functions in the limits of the integral. Let  $f(x, t) : P = [a, b] \times [c, d] \rightarrow \mathbb{R}$  be a continuous function and continuously differentiable with respect to the second variable (i.e.  $\frac{\partial f}{\partial t}$  exists everywhere on  $P$ ). Also, let  $\alpha, \beta : [c, d] \rightarrow [a, b]$  be two differentiable functions. In this case, the function

$$F(t) := \int_{\alpha(t)}^{\beta(t)} f(x, t) \, dx$$

is differentiable on  $[c, d]$  and

$$F'(t) = \frac{dF(t)}{dt} = \int_{\alpha(t)}^{\beta(t)} \frac{\partial f}{\partial t} \, dx + f(\beta(t), t)\beta'(t) - f(\alpha(t), t)\alpha'(t)$$



### 1.1.5 Simplified (Restricted) Fubini's Theorem for Double Integration

Define the finite constants  $a, b, c, d \in \mathbb{R}$  and let  $f(x, t) : P = [a, b] \times [c, d] \rightarrow \mathbb{R}$  be a continuous function. Note that the rectangle  $P$  on which  $f$  is defined is bounded. In this case

$$\int_a^b \left( \int_c^d f(x, y) dy \right) dx = \int_c^d \left( \int_a^b f(x, y) dx \right) dy$$

The general form of Fubini's theorem, given later in this section, extends to functions with an unbounded domain.

## 1.2 Improper Parameter-Dependent Integrals

### 1.2.1 Definition: Uniform Convergence of an Improper Parameter-Dependent Integral

Let  $f : [a, \infty) \times [c, d] \rightarrow \mathbb{R}$  be a continuous function. In this case, the parameter-dependent integral

$$F(t) = \int_a^\infty f(x, t) dx$$

converges uniformly on the interval  $[c, d]$  if for all  $\epsilon > 0$  there exists  $M_0 \in \mathbb{R}$ ;  $M_0 \geq a$  such that

$$\left| \int_M^\infty f(x, t) dx \right| < \epsilon$$

for all  $t \in [c, d]$  and for all  $M > M_0$ .

### 1.2.2 Proposition: Condition for Uniform Convergence

Let  $f : [a, \infty) \times [c, d] \rightarrow \mathbb{R}$  be a continuous function. Assume also there exists an integrable function  $\phi : [a, \infty) \times [0, \infty)$  such that  $|f(x, t)| \leq \phi(x)$  for all  $x \geq a$  and for all  $t \in [c, d]$ . In this case the parameter-dependent integral

$$F(t) := \int_a^\infty f(x, t) dx$$

converges uniformly on the interval  $[c, d]$ .

### 1.2.3 Proposition: Uniform Convergence Implies Continuity

Let  $f : [a, \infty) \times [c, d] \rightarrow \mathbb{R}$  be a continuous function and let the parameter-dependent integral

$$F(t) := \int_a^\infty f(x, t) dx$$

converge uniformly on the interval  $[c, d]$ . In this case  $F$  is continuous on  $[c, d]$ .

### 1.2.4 Proposition: Uniform Convergence Implies Integrability

Let  $f : [a, \infty) \times [c, d] \rightarrow \mathbb{R}$  be a continuous function and let the parameter-dependent integral

$$F(t) := \int_a^\infty f(x, t) dx$$

converge uniformly on the interval  $[c, d]$ . In this case  $F$  is integrable on  $[c, d]$  and

$$\int_c^d \left( \int_a^\infty f(x, t) dx \right) dt = \int_a^\infty \left( \int_c^d f(x, t) dt \right) dx$$

### 1.2.5 Example: An Identity for $\ln\left(\frac{d}{c}\right)$ Using Double Integration

Let  $F(t)$  be the parameter-dependent integral given by

$$F(t) := \int_0^\infty e^{-tx} dx \quad \text{where } 0 < t < \infty$$

and define the constants  $c, d \in \mathbb{R}$  such that  $0 < c \leq t \leq d < \infty$ .

Without proof, the  $F$  converges uniformly on  $[c, d]$  by the definition of uniform convergence. Because  $F$  converges uniformly, it is also continuous and integrable on  $[c, d]$ . Using analysis techniques from Matematika 1 we can calculate

$$F(t) = \frac{1}{t} \quad \text{and} \quad \int_c^d F(t) dt = \int_c^d \frac{1}{t} dt = \ln(t) \Big|_c^d = \ln\left(\frac{d}{c}\right)$$

(Because  $t$  is positive, we drop the absolute value in the logarithm). By applying the previous proposition and making use of double integration, we can show that

$$\begin{aligned} \int_c^d F(t) dt &= \int_c^d \int_0^\infty e^{-tx} dx dt = \int_0^\infty \int_c^d e^{-tx} dt dx \\ &= \int_0^\infty \frac{e^{-tx} \Big|_{t=c}^d}{-x} dx = \int_0^\infty \frac{e^{-dx} - e^{-cx}}{-x} dx \\ &= \int_0^\infty \frac{e^{-cx} - e^{-dx}}{x} dx \end{aligned}$$

Note that in the derivation, we used the indefinite integral identity

$$\int e^{-tx} dt = \frac{e^{-tx}}{-x} + C$$

It follows from the above discussion that

$$\int_0^\infty \frac{e^{-cx} - e^{-dx}}{x} dx = \ln\left(\frac{d}{c}\right) \quad \forall \quad c, d > 0$$

### 1.2.6 Theorem: Differentiability of Improper Parameter-Dependent Integrals

Let  $f : [a, \infty) \times [c, d] \rightarrow \mathbb{R}$  be a continuous function such that:

1.  $f$ 's partial derivative with respect to  $t$ , given by  $\frac{\partial f}{\partial t} : [a, \infty) \times [c, d] \rightarrow \mathbb{R}$  is continuous on  $[c, d]$ .
2. For all  $t \in [c, d]$  the function  $F(t)$  given by

$$F(t) := \int_a^\infty f(x, t) dx$$

exists. Note that the existence of  $F(t)$  is not necessarily trivial.

3. The function  $G(t)$  given by

$$G(t) := \int_a^\infty \frac{\partial f(x, t)}{\partial t} dx$$

converges uniformly on the interval  $[c, d]$ .

In this case  $F$  is differentiable on  $[c, d]$  and

$$F'(t) = \frac{dF(t)}{dt} = G(t)$$

or, more thoroughly,

$$\frac{d}{dt} \int_a^\infty f(x, t) dx = \int_a^\infty \frac{\partial f(x, t)}{\partial t} dx$$

### 1.2.7 Theorem: General Form of Fubini's Theorem

Define the constants  $a, b, c, d \in \mathbb{R} \cup \{-\infty, \infty\}$  and let  $f$  be a continuous function such that either  $f(x, t) \geq 0$  for all  $x, t \in \mathbb{R}$  or

$$\int_a^b \int_c^d |f(x, t)| dt dx < \infty$$

In this case,

$$\int_a^b \int_c^d |f(x, t)| dt dx = \int_c^d \int_a^b |f(x, t)| dx dt$$

### 1.2.8 Example: Evaluating the Dirichlet integral

We aim to evaluate the Dirichlet integral

$$I = \int_0^\infty \frac{\sin x}{x} dx$$

using double integration and the ideas of the past sections. First, define a new function of  $I(t)$  given by:

$$I(t) := \int_0^\infty \frac{\sin x}{x} e^{-tx} dx \tag{1.1}$$

Without proof, we note that for  $t > 0$  the integral represented by  $I(t)$  converges absolutely, permitting us to differentiate with respect to  $t$  inside the integral for values of  $t > 0$ .

$$I'(t) = \int_0^\infty \frac{\partial}{\partial t} \frac{\sin x}{x} e^{-tx} dx = - \int_0^\infty e^{-tx} \sin x dx$$

Evaluating the integral by parts yields

$$I'(t) = \frac{e^{-tx} (t \sin x + \cos x)}{t^2 + 1} \Big|_{x=0}^{x=\infty} = -\frac{1}{t^2 + 1}$$

Thus

$$\begin{aligned} I(t) &= \int I'(t) = \int -\frac{1}{t^2 + 1} dt = -\arctan t + C \\ I(t) &= -\arctan t + C \end{aligned} \tag{1.2}$$

From Equation 1.1 we see that

$$\lim_{t \rightarrow \infty} I(t) = 0$$

Meanwhile from Equation 1.2 we see that

$$\lim_{t \rightarrow \infty} I(t) = \lim_{t \rightarrow \infty} (-\arctan t + C)$$

From which follows that

$$\begin{aligned} 0 &= -\frac{\pi}{2} + C \\ C &= \frac{\pi}{2} \\ I(t) &= -\arctan t + \frac{\pi}{2} \\ I(0) &= \frac{\pi}{2} \end{aligned} \tag{1.3}$$

Referring back to Equation 1.1, we also see that

$$I(0) = \int_0^{\infty} \frac{\sin x}{x} e^{-(0)x} dx = \int_0^{\infty} \frac{\sin x}{x} dx$$

Plugging in the value from Equation 1.3 gives

$$\int_0^{\infty} \frac{\sin x}{x} dx = \frac{\pi}{2}$$

Note, again without proof, that because of the uniform convergence of  $I(t)$  on a small interval  $[0, \tau)$ ,  $\tau > 0$  around  $t = 0$  we are justified in extending our derivation of  $I = \frac{\pi}{2}$  from values of  $t > 0$  to value of  $t \geq 0$ .

### 1.2.9 Note: Weierstrass Test for Uniform Convergence

Let  $[c, d] \in \mathbb{R}$  be finite constants such that  $c < d$  and let  $F(y)$  be the function given by:

$$F(y) = \int_a^{\infty} f(x, y) dx \quad y \in [c, d]$$

More so, let  $W : [a, \infty] \rightarrow [0, \infty]$  be a non-negative function of  $x$  such that the improper integral

$$\int_0^{\infty} W(x) dx$$

converges. In this case, if

$$|f(x, y)| \leq W(x) \quad \forall \quad y \in [c, d]$$

then  $F(y)$  converges uniformly for all  $y \in [c, d]$ .

## 1.3 The Gamma and Beta Functions

### 1.3.1 Definition of the Gamma Function

For  $t > 0$  we define the gamma function  $\Gamma$  as:

$$\Gamma(t) := \int_0^{\infty} x^{t-1} e^{-x} dx$$

The gamma function is locally uniformly convergent for all  $x$  in the interval  $(0, \infty)$ .

### 1.3.2 Properties of the Gamma Function

1. The gamma function is a smooth function, meaning all of its derivatives with respect to  $t$  are continuous functions i.e.  $\Gamma \in C^\infty$

2.  $\Gamma(1) = 1 \quad \Gamma\left(\frac{1}{2}\right) = \sqrt{\pi}$

3.

$$\Gamma(t+1) = \int_0^\infty x^t e^{-x} dx = -x^t e^{-x} \Big|_{x=0}^{x=\infty} + t \int_0^\infty x^{t-1} e^{-x} dx = t\Gamma(t)$$

4. It follows from  $\Gamma(t+1) = t\Gamma(t)$  that  $\Gamma(1) = 1$  that:

$$\Gamma(2) = 1 \cdot \Gamma(1) = 1$$

$$\Gamma(3) = 2 \cdot \Gamma(2) = 2$$

$$\Gamma(4) = 3 \cdot \Gamma(3) = 6$$

⋮

$$\Gamma(n) = (n-1)! \quad \forall n \in \mathbb{N}^+$$

### 1.3.3 Definition of the Beta Function

For real numbers  $p, q > 0$  we define the beta function  $B$  as

$$B(p, q) := \int_0^1 x^{p-1} (1-x)^{q-1} dx$$

### 1.3.4 Proposition: Trigonometric Definition of the Beta Function

For all real numbers  $\alpha, \beta > 0$ , we can alternatively define the beta function with the relationship:

$$\frac{1}{2} B\left(\frac{\alpha}{2}, \frac{\beta}{2}\right) = \int_0^{\pi/2} (\sin x)^{\alpha-1} (\cos x)^{\beta-1} dx$$

or equivalently

$$B(p, q) = 2 \int_0^{\pi/2} (\sin x)^{2p-1} (\cos x)^{2q-1} dx$$

### 1.3.5 Proposition: Identity for the Beta Function

$$B(p, q) = \int_0^\infty \frac{u^{p-1}}{(1+u)^{p+q}} dy$$

Proof: By applying the change of variables

$$\begin{aligned} x &= \frac{u}{1+u} & 1-x &= \frac{1}{1+u} & dx &= \frac{du}{1+u} \\ u(x=0) &= 0 & u(x=1) &= \infty \end{aligned}$$

to the definition of the beta function we obtain

$$\begin{aligned} B(p, q) &= \int_0^1 x^{p-1} (1-x)^{q-1} dx = \int_0^\infty \frac{u^{p-1}}{(1+u)^{p-1}} \frac{1}{(1+u)^{q-1}} \frac{1}{(1+u)^2} \\ &= \int_0^\infty \frac{u^{p-1}}{(1+u)^{(p-1)+(q-1)+2}} = \int_0^\infty \frac{u^{p-1}}{(1+u)^{p+q}} dy \end{aligned}$$

### 1.3.6 Theorem: Relationship Between the Gamma and Beta Function

The gamma and beta functions are related by the relationship:

$$B(p, q) = \frac{\Gamma(p)\Gamma(q)}{\Gamma(p+q)}$$

### 1.3.7 Consequence: The Identity $\Gamma(1/2) = \sqrt{\pi}$

Applying the above theorem with  $p = q = 1/2$  and referring to the trigonometric definition of the beta function we obtain

$$\begin{aligned} \frac{\Gamma(\frac{1}{2})\Gamma(\frac{1}{2})}{\Gamma(1)} &= B\left(\frac{1}{2}, \frac{1}{2}\right) = 2 \int_0^{\pi/2} (\sin x)^{(2\frac{1}{2}-1)}(\cos x)^{(2\frac{1}{2}-1)} dx \\ &= 2 \int_0^{\pi/2} dx = 2 \left(\frac{\pi}{2}\right) = \pi \end{aligned}$$

It follows that

$$\begin{aligned} \frac{\Gamma(\frac{1}{2})\Gamma(\frac{1}{2})}{\Gamma(1)} &= \left(\Gamma\left(\frac{1}{2}\right)\right)^2 = \pi \\ \Gamma(1/2) &= \sqrt{\pi} \end{aligned}$$

Without proof, a more general identity is

$$B(p, 1-p) = \Gamma(p)\Gamma(1-p) = \frac{\pi}{\sin(p\pi)}$$

### 1.3.8 Theorem: Stirling's Formula

Stirling's formula gives a good approximation for the factorial function and provides a measure of the approximation's accuracy. Additionally, Stirling's formula generalizes the factorial function from the positive integers to the positive real numbers.

$$\lim_{x \rightarrow \infty} \frac{x!}{\left(\frac{x}{e}\right)^x \sqrt{x}} = \sqrt{2\pi}$$

so

$$x! = \Gamma(x+1) \sim \left(\frac{x}{e}\right)^x \sqrt{2\pi x}$$

## 2 Multiple Riemann Integration

### 2.1 Introduction to Riemann Integrability

#### 2.1.1 Definition: Partition of a Rectangle $P$

Let  $P$  be a rectangle defined by

$$P := [a, b] \times [c, d] \in \mathbb{R}^2$$

and  $f : P \rightarrow [0, \infty)$  be a bounded, continuous function.

To form a partition of  $P$ , we split the interval  $[a, b]$  into  $n$  parts given by  $a = x_0 < x_1 < \dots < x_{n-1} < x_n = b$  and split the interval  $[c, d]$  into  $m$  parts given by  $c = y_0 < y_1 < \dots < y_{m-1} < y_m = d$ . Next, we create an arbitrary rectangle  $P_{jk}$ , which is a sub-rectangle of  $P$ , defined by

$$P_{jk} := [x_{j-1}, x_j] \times [y_{k-1}, y_k]$$

In this case,  $D = \{P_{jk}; j \in \{1, \dots, n\} k \in \{1, \dots, m\}\}$ , the set of all sub-rectangles  $P_{jk}$ , is a partition of  $P$ .

#### 2.1.2 Definition: Upper and Lower Sums

Let  $P$  be a rectangle defined by

$$P := [a, b] \times [c, d] \in \mathbb{R}^2$$

and  $f : P \rightarrow [0, \infty)$  be a bounded function and let  $D$  be a partition of  $P$ .

Let  $m_{jk} = \inf f(x, y), (x, y) \in P_{jk}$ , written shorthand as  $\inf_{P_{jk}} f$ , be the infimum of  $f$  on the rectangle  $P_{jk}$  and let  $M_{jk} = \sup f(x, y), (x, y) \in P_{jk}$ , written shorthand as  $\sup_{P_{jk}} f$ , be the supremum of  $f$  on the rectangle  $P_{jk}$ . In this case the lower and upper sums of  $f$  on the partition  $D$ , denoted by  $s(f, D)$  and  $S(f, D)$  respectively, are:

$$s(f, D) := \sum_{j,k} m_{jk} A(P_{jk})$$

$$S(f, D) := \sum_{j,k} M_{jk} A(P_{jk})$$

where  $A(P_{jk})$  denotes the area of the rectangle  $P_{jk}$ .

#### 2.1.3 Definition: Riemann Sum

Let  $P$  be a rectangle defined by  $P := [a, b] \times [c, d] \in \mathbb{R}^2$ , let  $f : P \rightarrow [0, \infty)$  be a bounded function, and let  $D$  be an arbitrary partition of  $P$ .

Next, for each sub-rectangle  $P_{jk}$  we choose a point  $\xi_{jk} \in P_{jk}$  inside the rectangle, and let  $\xi := \{\xi_{jk}; j, k\}$  be the set of all such points  $\xi_{jk}$ . In this case, the Riemann sum of  $f$  for the partition  $D$  and set of points  $\xi$ , denoted by  $R(f, D, \xi)$ , is defined as:

$$R(f, D, \xi) := \sum_{j,k} f(\xi_{jk}) A(P_{jk})$$

where  $A(P_{jk})$  denotes the area of the rectangle  $P_{jk}$ .

#### 2.1.4 Proposition: Effect of Refinement on Upper and Lower Sums

Let  $P$  be a rectangle defined by  $P := [a, b] \times [c, d] \in \mathbb{R}^2$ , let  $f : P \rightarrow [0, \infty)$  be a bounded function, and let  $D$  and  $D'$  be partitions of  $P$  such that  $D'$  is finer than  $D$ . In this case,

$$s(f, D) \leq s(f, D') \leq S(f, D') \leq S(f, D)$$

In other words, refinement of a partition causes the upper and lower sums  $S$  and  $s$  to become closer together in value.

#### 2.1.5 Consequence: Relationship Between Upper and Lower Sums

Let  $P$  be a rectangle defined by  $P := [a, b] \times [c, d] \in \mathbb{R}^2$ , let  $f : P \rightarrow [0, \infty)$  be a bounded function, and let  $D_1$  and  $D_2$  be arbitrary partitions of  $P$ . In this case,

$$s(f, D_1) \leq S(f, D_2)$$

In other words, every lower sum  $s$  is less than or equal to every upper sum  $S$ , regardless of partition. Proof: Let  $D'$  be a finer partition than both  $D_1$  and  $D_2$ . Applying the above proposition, we see that:

$$s(f, D_1) \leq s(f, D') \leq S(f, D') \leq S(f, D_2)$$

so  $s(f, D_1) \leq S(f, D_2)$ .

#### 2.1.6 Definition: Riemann Integrability

Let  $P$  be a rectangle defined by  $P := [a, b] \times [c, d] \in \mathbb{R}^2$ , let  $f : P \rightarrow [0, \infty)$  be a bounded function, and let  $D$  be an arbitrary partition of  $P$ .

More so, let  $s(f) := \sup_D s(f, D)$  and  $S(f) := \inf_D S(f, D)$  be the largest lower sum and smallest upper sum, respectively, of  $f$  over all possible partitions  $D$ . In this case,  $f$  is Riemann-integrable if

$$s(f) = S(f) \quad (\text{condition for Riemann integrability})$$

Epsilon-delta definition:  $f$  is Riemann-integrable on the rectangle  $P$  if for each  $\epsilon > 0$  there exists  $\delta > 0$  such that for each partition  $D$  of  $P$  where the area of each partition  $A(D_{jk}) < \delta$  for each  $j, k$  it follows that for each point  $\xi_{jk} \in D_{jk}$  forming the set  $\xi = \{\xi_{jk}; j, k\}$  the Riemann sum

$$|R(f, D, \xi) - I| < \epsilon$$

#### 2.1.7 Definition: Riemann Sum

Let  $P$  be a rectangle defined by  $P := [a, b] \times [c, d] \in \mathbb{R}^2$ , let  $f : P \rightarrow [0, \infty)$  be a bounded function, and let  $D$  be an arbitrary partition of  $P$ .

If  $f$  is Riemann-integrable by the previous definition, the  $s(f) = S(f)$  are  $f$ 's Riemann sum on the partition  $D$ . It follows that Riemann integrability on a partition implies the existence of the Riemann sum on that partition.

If  $f$  is Riemann-integrable on the partition  $D$  of the rectangle  $f$ , we write the Riemann integral as

$$\iint_P f(x, y) \, dx \, dy \quad \text{or more concisely} \quad \iint_P f \, dS$$

Note: For the remainder of this chapter, integrability is assumed to mean Riemann-integrability.



**2.1.8 Lemma: Condition for Integrability**

Let  $P$  be a rectangle defined by  $P := [a, b] \times [c, d] \in \mathbb{R}^2$ , let  $f : P \rightarrow [0, \infty)$  be a bounded function, and let  $D$  be an arbitrary partition of  $P$ . In this case,  $f$  is integrable on  $P$  if for each  $\epsilon > 0$  there exists partition  $D$  of  $P$  such that

$$S(f, D) - s(f, D) < \epsilon$$

**2.1.9 Theorem: Continuity Implies Integrability**

Let  $P$  be a rectangle defined by  $P := [a, b] \times [c, d] \in \mathbb{R}^2$  and let  $f : P \rightarrow [0, \infty)$  be a bounded function. In this case, if  $f$  is continuous,  $f$  is also integrable.

**2.1.10 Theorem: Properties of Integrable Functions**

Let  $P$  be a rectangle defined by  $P := [a, b] \times [c, d] \in \mathbb{R}^2$  and let  $f, g : P \rightarrow [0, \infty)$  be integrable functions. In this case:

1. The function  $f + g$  is integrable.
2. The function  $cf$  is integrable for each  $c \in \mathbb{R}$ .

Additionally, if  $f \leq g$  for all  $x, y \in P$  then

$$\iint_P f(x, y) \, dx \, dy \leq \iint_P g(x, y) \, dx \, dy$$

Finally, assuming  $f$  is integrable,  $|f|$  is also integrable and

$$\left| \iint_P f(x, y) \, dx \, dy \right| \leq \iint_P |f(x, y)| \, dx \, dy$$

**2.2 Volume****2.2.1 Definition: Volume for a Function on a Rectangle in  $\mathbb{R}$** 

Let  $P$  be a rectangle defined by  $P := [a, b] \times [c, d] \in \mathbb{R}^2$  and let  $f : P \rightarrow [0, \infty)$  be a continuous, bounded function. In this case, the volume  $V$  of the three dimensional body bounded by the graph of  $f$ , given by the set of points  $\{(x, y, z); (x, y) \in P, 0 \leq z \leq f(x, y)\}$  is defined as

$$V = \iint_P f(x, y) \, dx \, dy$$

**2.2.2 Note: Volume for a Function on a Rectangle in  $\mathbb{R}^n$** 

This proposition generalizes the previous definition to hyper-rectangles of arbitrary dimension. Let  $P \subset \mathbb{R}^n$  be a bounded hyper-rectangle in  $\mathbb{R}^n$  and let  $f : P \rightarrow [0, \infty)$  be a continuous, bounded function. In this case, the volume  $V$  of the body bounded by the graph of  $f$  is defined as

$$V = \iint \dots \int_P^n f(x_1, x_2, \dots, x_n) \, dx_1 \, dx_2 \dots dx_n$$

**2.2.3 Proposition: Volume for a Function on an Arbitrary Set**

Let  $A \subset \mathbb{R}^n$  be an arbitrary bounded subset of  $\mathbb{R}^n$  and let  $P \subset \mathbb{R}^n$  be an arbitrary bounded hyper-rectangle containing  $A$  i.e.  $A \subset P$ . More so, let  $f : A \rightarrow [0, \infty)$  be a continuous, bounded function defined on  $A$  and let  $\tilde{f} : P \rightarrow [0, \infty)$  be a generalization of  $f$  given by

$$\tilde{f} := \begin{cases} f(x) & x \in A \\ 0 & x \in P \setminus A \end{cases}$$

In this case, assuming the integrals exist,

$$\int_A f(x) \, dx = \int_P \tilde{f}(x) \, dx$$

where  $x \in \mathbb{R}^n$  is an arbitrary element of  $\mathbb{R}^n$ .

**2.2.4 Definition:  $n$ -Dimensional Volume**

By definition, the bounded set  $A \subset \mathbb{R}^n$  has  $n$ -dimensional volume if the function 1 is integrable on  $A$ . In this case

$$V(A) := \int_A 1 \, dx$$

where  $x \in \mathbb{R}^n$  is an arbitrary element of  $\mathbb{R}^n$ .

**2.2.5 Theorem: Condition for  $n$ -Dimensional Volume**

The bounded set  $A \subset \mathbb{R}^n$  has  $n$ -dimensional volume if the volume of its boundary, denoted by  $\partial A$ , is zero. That is,  $A$  has  $n$ -dimensional volume if  $V(\partial A) = 0$ .

**2.2.6 Note: Condition for Zero  $n$ -Dimensional Volume**

The bounded set  $A \subset \mathbb{R}^n$  has  $n$ -dimensional volume equal to zero if for each  $\epsilon > 0$

1. There exist hyper-rectangles  $P_1, P_2, \dots, P_n$  such that the union of the hyper-rectangles contains  $A$  i.e.  $A \subset \bigcup P_j \quad j \in \{1, 2, \dots, n\}$  and
2. The sum of the volumes of the hyper-rectangles is less than  $\epsilon$ , written

$$\sum_j V(P_j) < \epsilon$$

**2.2.7 Proposition: Finite Union of Sets with Zero Volume**

Any bounded set consisting of a finite union of bounded subsets with  $n$ -dimensional volume equal to zero has  $n$ -dimensional volume equal to zero. More formally, let  $m \in \mathbb{Z}$  be a finite integer, let

$$A_1, A_2, \dots, A_m \subset \mathbb{R}^n \quad | \quad V(A_i) = 0$$

be  $m$  bounded sets with  $n$ -volume equal to zero and let  $A \subset \mathbb{R}^n$  be the bounded set given by

$$A = A_1 \cup A_2 \cup \dots \cup A_m$$

In this case  $V(A) = 0$ .

**2.2.8 Proposition: The Graph of a Function Has Zero  $n$ -Volume**

Let  $K \subset \mathbb{R}^n$  be a bounded subset of  $\mathbb{R}^n$  and let  $f : K \rightarrow \mathbb{R}$  be an integrable function. In this case, the graph  $\mathcal{G}(f)$  of  $f$ , given by

$$\mathcal{G}(f) := \{(x, f(x)) \in \mathbb{R}^{n+1}; x \in K\} \subset \mathbb{R}^n \times \mathbb{R} \equiv \mathbb{R}^{n+1}$$

has zero volume in  $\mathbb{R}^{n+1}$ .

**2.2.9 Integral Over a Set with Zero Volume**

Let  $K \subset \mathbb{R}^n$  be a bounded hyper-rectangle in  $\mathbb{R}^n$ , let  $A \subset K$  be a subset of  $K$  such that  $A$  has zero  $n$ -volume i.e.  $V(A) = 0$ , and let  $f : K \rightarrow \mathbb{R}$  be a bounded function whose restriction to the set  $K \setminus A$  is zero everywhere on its domain, i.e.

$$f|_{K \setminus A} = 0$$

In this case, the integral of  $f$  over the set  $K$  equals zero, i.e.

$$\int_K f(x) dx = 0$$

where  $x \in \mathbb{R}^n$  is an element of  $\mathbb{R}^n$ .

**2.2.10 Implication: Integral Over a Set with Zero Volume**

Let  $K \subset \mathbb{R}^n$  be a bounded hyper-rectangle in  $\mathbb{R}^n$ , let  $f : K \rightarrow \mathbb{R}$  be a bounded, integrable function, and let  $A \subset K$  be a subset of  $K$  with zero  $n$ -volume, i.e.  $V(A) = 0$ . More so, define the function  $\tilde{f}$  given by

$$\tilde{f} = \begin{cases} f(x) & x \in K \setminus A \\ \phi(x) & x \in A \end{cases}$$

where  $\phi(x) \rightarrow \mathbb{R}$  is an arbitrary bounded function that can take on any finite value in  $\mathbb{R}$ . In this case

$$\int_K f(x) dx = \int_K \tilde{f}(x) dx$$

where  $x \in \mathbb{R}^n$  is an element of  $\mathbb{R}^n$ .

**2.3 Zero Measure**

**2.3.1 Definition: Set with Zero Measure**

Let  $A \subset \mathbb{R}^n$  be an arbitrary subset of  $\mathbb{R}^n$ , noting that  $A$  is not necessarily bounded. In this case the subset  $A$  has measure zero on  $\mathbb{R}^n$ , denoted by  $m(A) = 0$ , if for each  $\epsilon > 0$  there exist countably many hyper-rectangles  $A_j$  such that

$$A \subset A_1 \cup A_2 \cup \dots \cup A_j$$

and

$$\sum_j V(A_j) < \epsilon$$

.

### 2.3.2 Note: Zero $n$ -Volume Implies Zero Measure

Let  $A \subset \mathbb{R}^n$  be an arbitrary subset of  $\mathbb{R}^n$  such that  $A$  has zero  $n$ -volume. In this case, the measure of  $A$  on  $\mathbb{R}^n$  is zero. In symbols,

$$V(A) = 0 \implies m(A) = 0$$

### 2.3.3 Proposition: Union of Sets with Zero Measure

Any set consisting of a countable union of subsets with measure zero on  $\mathbb{R}^n$  also has zero measure on  $\mathbb{R}^n$ . More formally, let  $m \in \mathbb{Z} \cup \{\infty\}$  be a countable number, let

$$A_1, A_2, \dots, A_m \subset \mathbb{R}^n \quad | \quad m(A_i) = 0$$

be  $m$  sets with zero measure on  $\mathbb{R}^n$  and let  $A \subset \mathbb{R}^n$  be the set given by

$$A = A_1 \cup A_2 \cup \dots \cup A_m$$

In this case  $m(A) = 0$ .

### 2.3.4 Theorem: Measure and Integrability

Let  $A \subset \mathbb{R}^n$  be a bounded subset of  $\mathbb{R}^n$  and define the function  $f : A \rightarrow \mathbb{R}$ . In this case,  $f$  is integrable on  $A$  if, and only if, the set of all of  $f$ 's discontinuities has measure zero on  $\mathbb{R}^n$ .

### 2.3.5 Note: Almost Everywhere

A statement is said to hold *almost everywhere* (abbreviated *a.e.*) on a set  $K \subset \mathbb{R}^n$  if the statement holds everywhere on  $K$  except possibly on a subset of  $K$  with zero measure.

### 2.3.6 Proposition: Compact Set and Zero Measure

Let  $A \subset \mathbb{R}^n$  be a subset of  $\mathbb{R}^n$ . If  $A$  is compact, then  $A$  having zero measure is equivalent to  $A$  having zero volume.

$$m(A) = 0 \iff V(A) = 0 \quad (A \text{ is compact})$$

## 2.4 Integrals Over Bounded Sets

### 2.4.1 Theorem: Properties of Integrals Over Bounded Sets

Let  $A \subset \mathbb{R}^n$  be a bounded subset of  $\mathbb{R}^n$ , let  $f, g : A \rightarrow \mathbb{R}$  be two bounded functions, and let  $x \in A$  denote an element of  $A \subset \mathbb{R}^n$ . In this case:

- If  $f$  and  $g$  are integrable on  $A$ , then  $f + g$  is also integrable on  $A$  and:

$$\int_A (f + g)(x) \, dx = \int_A f(x) \, dx + \int_A g(x) \, dx$$

- If  $f$  and  $g$  are integrable on  $A$  and  $f \leq g$  for each  $x \in A$  then:

$$\int_A f(x) \, dx \leq \int_A g(x) \, dx$$

- If  $f$  is integrable on  $A$  then  $|f|$  is also integrable on  $A$  and:

$$\left| \int_A f(x) \, dx \right| \leq \int_A |f(x)| \, dx$$

- If  $f$  is integrable on  $A$  and  $A$  has  $n$ -volume in  $\mathbb{R}^n$  then:

$$\left| \int_A f(x) \, dx \right| \leq \sup_{x \in A} |f(x)| V(A)$$

- Let  $A, B \subset \mathbb{R}^n$  be two bounded subsets of  $\mathbb{R}^n$  such that  $V(A \cap B) = 0$  and let the function  $f : A \cup B \rightarrow \mathbb{R}$  be bounded and integrable on both  $A$  and  $B$ . In this case, the integral of  $f$  over  $A \cup B$  also exists and:

$$\int_{A \cup B} f(x) \, dx = \int_A f(x) \, dx + \int_B f(x) \, dx$$

#### 2.4.2 Note: Average Value of a Function on a Set

Let  $A \subset \mathbb{R}^n$  be a bounded subset of  $\mathbb{R}^n$  such that  $V(A) > 0$  and let  $f : A \rightarrow \mathbb{R}$  be a bounded, integrable function. In this case, the average value  $\bar{f}$  of  $f$  on  $A$  is given by:

$$\bar{f} = \frac{1}{V(A)} \int_A f(x) \, dx$$

#### 2.4.3 Proposition: Integral Over a Set Equal to Zero

Let  $A \subset \mathbb{R}^n$  be a bounded subset of  $\mathbb{R}^n$  and let  $f : A \rightarrow [0, \infty)$  be a function such that

$$\int_A f(x) \, dx = 0$$

In this case  $f(x) = 0$  almost everywhere on  $A$ .

#### 2.4.4 Theorem: Fubini's Theorem III

Let  $P = [a, b] \times [c, d] \in \mathbb{R}^2$  be a rectangle in  $\mathbb{R}^2$ , let  $f : P \rightarrow \mathbb{R}$  be an integrable function, and let  $f(x, \bullet) : [c, d] \rightarrow \mathbb{R}$  mapping  $y \mapsto f(x, y)$  be integrable on  $[c, d]$  for each  $x \in [a, b]$ . In this case:

$$\iint_P f(x, y) \, dx \, dy = \int_a^b \int_c^d f(x, y) \, dy \, dx$$

#### 2.4.5 Implication: Iterated Integral Over a Rectangle in $\mathbb{R}^2$

Let  $P = [a, b] \times [c, d] \in \mathbb{R}^2$  be a rectangle in  $\mathbb{R}^2$ , let  $f : P \rightarrow \mathbb{R}$  be an integrable function, and let  $f(x, \bullet) : [c, d] \rightarrow \mathbb{R}$  mapping  $y \mapsto f(x, y)$  be integrable on  $[c, d]$  for each  $x \in [a, b]$ . If  $f$  is continuous on  $P$ , then:

$$\int_c^d \int_a^b f(x, y) \, dx \, dy = \iint_P f(x, y) \, dx \, dy = \int_a^b \int_c^d f(x, y) \, dy \, dx$$

**2.4.6 Proposition: Iterated Integral Over an Arbitrary Set in  $\mathbb{R}^2$**

Let  $\alpha, \beta : [a, b] \rightarrow \mathbb{R}$  be two continuous functions such that  $\alpha(x) < \beta(x)$  for each  $x \in [a, b]$ , let  $A \subset \mathbb{R}^2$  be the set given by:

$$A = \{(x, y) \in \mathbb{R}^2 \mid a \leq x \leq b, \alpha(x) \leq y \leq \beta(x)\}$$

and let  $f : A \rightarrow \mathbb{R}$  be a continuous function. In this case

$$\iint_A f(x, y) \, dx \, dy = \int_a^b \int_{\alpha(x)}^{\beta(x)} f(x, y) \, dy \, dx$$

**2.4.7 Theorem: Iterated Integral Over a Hyper-Rectangle in  $\mathbb{R}^3$**

Let  $K = [a_1, b_1] \times [a_2, b_2] \times [a_3, b_3] \in \mathbb{R}^3$  be a hyper-rectangle in  $\mathbb{R}^3$ , let  $f : K \rightarrow \mathbb{R}$  be a continuous function, and let  $P = [a_1, b_1] \times [a_2, b_2] \subset \mathbb{R}^2$ . In this case:

$$\begin{aligned} \iiint_K f(x, y, z) \, dx \, dy \, dz &= \iint_P \left( \int_{a_3}^{b_3} f(x, y, z) \, dz \right) \, dx \, dy \\ &= \int_{a_1}^{b_1} \int_{a_2}^{b_2} \int_{a_3}^{b_3} f(x, y, z) \, dz \, dy \, dx \end{aligned}$$

**2.4.8 Proposition: Iterated Integral Over an Arbitrary Set in  $\mathbb{R}^3$**

Let  $A \in \mathbb{R}^2$  be a set in  $\mathbb{R}^2$  with definite area, let  $\alpha, \beta : A \rightarrow \mathbb{R}$  be two continuous functions such that  $\alpha(x, y) < \beta(x, y)$  for each  $(x, y) \in A$ , let  $B \subset \mathbb{R}^3$  be the set given by:

$$B = \{(x, y, z) \in A \times \mathbb{R} \mid \alpha(x, y) \leq z \leq \beta(x, y)\}$$

and let  $f : B \rightarrow \mathbb{R}$  be a continuous function. In this case:

$$\iiint_B f(x, y, z) \, dx \, dy \, dz = \iint_A \left( \int_{\alpha(x, y)}^{\beta(x, y)} f(x, y, z) \, dz \right) \, dx \, dy$$

**2.4.9 Example: Iterated Integral in  $\mathbb{R}^3$**

Let  $T : \mathbb{R}^3$  be the 3-dimensional body bounded by the planes  $x = 0$ ,  $y = 0$  and  $z = 2$ , and by the elliptic paraboloid  $z = x^2 + y^2$ , such that  $T$  is located in the first octant i.e.  $(x, y, z) \geq 0$ . The problem is to calculate the integral

$$I = \iiint_T x \, dx \, dy \, dz$$

We will solve the problem by recursively reducing the degree of the iterated integral. First, to convert the triple integral into a double integral, we define the set  $\Omega \in \mathbb{R}^2$  such that

$$\Omega = \text{pr}_{\mathbb{R}^2}^\perp(T)$$

is the orthogonal projection of the set  $T$  onto the Cartesian plane  $\mathbb{R}^2$  (i.e. the  $xy$  plane). We see that

$$\Omega = \{(x, y) \in \mathbb{R}^2 \mid x, y \geq 0 \text{ and } x^2 + y^2 \leq 2\}$$

Our original triple integral becomes

$$\begin{aligned} I &= \iiint_T x \, dx \, dy \, dz = \iint_{\Omega} \left( \int_{z=x^2+y^2}^2 x \, dz \right) dx \, dy \\ &= \iint_{\Omega} (2x - x^3 - xy^2) \, dx \, dy \end{aligned}$$

Next, we simplify the double integral over  $\Omega$  and apply the substitution  $u = 2 - x^2$  to obtain

$$\begin{aligned} I &= \iint_{\Omega} (2x - x^3 - xy^2) \, dx \, dy = \int \left( \int_{y=0}^{\sqrt{2-x^2}} (2x - x^3 - xy^2) \, dy \right) dx \\ &= \int_0^{\sqrt{2}} \frac{2}{3} (2 - x^2)^{\frac{3}{2}} x \, dx \stackrel{(u=2-x^2)}{=} \frac{1}{3} \int_0^2 u^{\frac{3}{2}} \, du = \frac{8\sqrt{2}}{15} \end{aligned}$$

#### 2.4.10 Definition: Jacobian Matrix and Determinant

Let  $A \subset \mathbb{R}^n$  be an open, bounded set with definite volume and let  $\Phi : A \rightarrow \mathbb{R}^n$  be a vector-valued function of differentiability class  $C^1$  with  $n$  scalar components

$$\Phi = (\Phi_1, \dots, \Phi_n) \quad \Phi_i : A \rightarrow \mathbb{R}$$

The function  $\Phi$ 's Jacobian matrix  $\mathbf{J}_{\Phi}(x)$  at the point  $x \in A$  is the  $n \times n$  matrix:

$$\mathbf{J}_{\Phi}(x) = \begin{bmatrix} \frac{\partial \Phi}{\partial x_1} & \cdots & \frac{\partial \Phi}{\partial x_n} \end{bmatrix} = \begin{bmatrix} \frac{\partial \Phi_1}{\partial x_1} & \cdots & \frac{\partial \Phi_1}{\partial x_n} \\ \vdots & \ddots & \vdots \\ \frac{\partial \Phi_n}{\partial x_1} & \cdots & \frac{\partial \Phi_n}{\partial x_n} \end{bmatrix}$$

The function  $\Phi$ 's Jacobian determinant  $\det(\mathbf{J}_{\Phi}(x))$  at the point  $x \in A$  is

$$\det(\mathbf{J}_{\Phi}(x)) = \det \begin{bmatrix} \frac{\partial \Phi}{\partial x_1} & \cdots & \frac{\partial \Phi}{\partial x_n} \end{bmatrix} = \det \begin{bmatrix} \frac{\partial \Phi_1}{\partial x_1} & \cdots & \frac{\partial \Phi_1}{\partial x_n} \\ \vdots & \ddots & \vdots \\ \frac{\partial \Phi_n}{\partial x_1} & \cdots & \frac{\partial \Phi_n}{\partial x_n} \end{bmatrix}$$

#### 2.4.11 Theorem: Change of Variables for Multiple Integration

Let  $A \subset \mathbb{R}^n$  be an open, bounded set with definite volume and let  $\Phi : A \rightarrow \mathbb{R}^n$  be an injective function of differentiability class  $C^1$  such that  $\Phi$  has a non-zero Jacobian determinant  $\det(\mathbf{J}_{\Phi}(x))$  for all  $x \in A$  and the function  $\mathbf{J}_{\Phi} : x \mapsto \det(\mathbf{J}_{\Phi}(x))$  mapping  $x \in A$  to the Jacobian determinant  $\det(\mathbf{J}_{\Phi}(x))$  is bounded for all  $x \in A$ . If the set  $\Phi(A) \subset \mathbb{R}^n$  is open and has definite  $n$ -volume, then the function  $f : \Phi(A) \rightarrow \mathbb{R}$  is integrable, the function with the mapping  $x \mapsto f(\Phi(x)) |\det(\mathbf{J}_{\Phi}(x))|$  is integrable, and:

$$\int_{\Phi(A)} f(x) \, dx = \int_A f(\Phi(t)) |\det(\mathbf{J}_{\Phi}(t))| \, dt$$

## 2.5 Integration in Polar, Cylindrical, and Spherical Coordinates

### 2.5.1 Note: Change of Variables to Polar Coordinates

Let  $\Phi : \mathbb{R}^+ \times [0, 2\pi) \rightarrow \mathbb{R}^2$  be the function transforming between polar coordinates  $(r, \phi)$  and Cartesian coordinates  $(x, y)$  with the scalar components:

$$\begin{aligned}x(r, \phi) &= r \cos \phi \\y(r, \phi) &= r \sin \phi\end{aligned}$$

The corresponding Jacobian matrix  $\mathbf{J}_\Phi$  for transformation from polar to Cartesian coordinates is

$$\mathbf{J}_\Phi(r, \phi) = \begin{bmatrix} \frac{\partial x}{\partial r} & \frac{\partial x}{\partial \phi} \\ \frac{\partial y}{\partial r} & \frac{\partial y}{\partial \phi} \end{bmatrix} = \begin{bmatrix} \cos \phi & -r \sin \phi \\ \sin \phi & r \cos \phi \end{bmatrix}$$

The Jacobian determinant  $\det \mathbf{J}_\Phi$  is

$$\det \mathbf{J}_\Phi = r \cos^2 \phi + r \sin^2 \phi = r(\cos^2 \phi + \sin^2 \phi) = r$$

If  $A \subset \mathbb{R}^2$  is an open, bounded set with definite volume and  $f : \mathbb{R}^2 \rightarrow \mathbb{R}$  is an integrable function, we convert between integration in Cartesian and polar coordinates using the formula:

$$\iint_{\Phi(A)} f(x, y) \, dx \, dy = \iint_A f(r \cos \phi, r \sin \phi) \, r \, dr \, d\phi$$

### 2.5.2 Note: Change of Variables to Cylindrical Coordinates

Let  $\Phi : \mathbb{R}^+ \times [0, 2\pi) \times \mathbb{R} \rightarrow \mathbb{R}^3$  be the function transforming between cylindrical coordinates  $(r, \phi, z)$  and Cartesian coordinates  $(x, y, z)$  with the scalar components:

$$\begin{aligned}x(r, \phi, z) &= r \cos \phi \\y(r, \phi, z) &= r \sin \phi \\z(r, \phi, z) &= z\end{aligned}$$

The corresponding Jacobian matrix  $\mathbf{J}_\Phi$  for transformation from cylindrical to Cartesian coordinates is:

$$\mathbf{J}_\Phi = \begin{bmatrix} \frac{\partial x}{\partial r} & \frac{\partial x}{\partial \phi} & \frac{\partial x}{\partial z} \\ \frac{\partial y}{\partial r} & \frac{\partial y}{\partial \phi} & \frac{\partial y}{\partial z} \\ \frac{\partial z}{\partial r} & \frac{\partial z}{\partial \phi} & \frac{\partial z}{\partial z} \end{bmatrix} = \begin{bmatrix} \cos \phi & -r \sin \phi & 0 \\ \sin \phi & r \cos \phi & 0 \\ 0 & 0 & 1 \end{bmatrix}$$

The Jacobian determinant  $\det \mathbf{J}_\Phi$  is:

$$\det \mathbf{J}_\Phi = r(\cos^2 \phi + \sin^2 \phi) = r$$

If  $A \subset \mathbb{R}^3$  is an open, bounded set with definite volume and  $f : \mathbb{R}^3 \rightarrow \mathbb{R}$  is an integrable function, we convert between integration in Cartesian and cylindrical coordinates using the formula:

$$\iiint_{\Phi(A)} f(x, y, z) \, dx \, dy \, dz = \iiint_A f(r \cos \phi, r \sin \phi, z) \, r \, dr \, d\phi \, dz$$



### 2.5.3 Note: Change of Variables to Spherical Coordinates

Let  $\Phi : \mathbb{R}^+ \times [0, \pi] \times [0, 2\pi) \rightarrow \mathbb{R}^3$  be the function transforming between polar coordinates  $(r, \theta, \phi)$  (where  $\theta$  is the azimuthal angle and  $\phi$  is the polar angle) and Cartesian coordinates  $(x, y, z)$  with the scalar components:

$$\begin{aligned}x(r, \theta, \phi) &= r \sin \theta \cos \phi \\y(r, \theta, \phi) &= r \sin \theta \sin \phi \\z(r, \theta, \phi) &= r \cos \theta\end{aligned}$$

The corresponding Jacobian matrix  $\mathbf{J}_\Phi$  for transformation from spherical to Cartesian coordinates is:

$$\mathbf{J}_\Phi = \begin{bmatrix} \frac{\partial x}{\partial r} & \frac{\partial x}{\partial \theta} & \frac{\partial x}{\partial \phi} \\ \frac{\partial y}{\partial r} & \frac{\partial y}{\partial \theta} & \frac{\partial y}{\partial \phi} \\ \frac{\partial z}{\partial r} & \frac{\partial z}{\partial \theta} & \frac{\partial z}{\partial \phi} \end{bmatrix} = \begin{bmatrix} \sin \theta \cos \phi & r \cos \theta \cos \phi & -r \sin \theta \sin \phi \\ \sin \theta \sin \phi & r \cos \theta \sin \phi & r \sin \theta \cos \phi \\ \cos \theta & -r \sin \theta & 0 \end{bmatrix}$$

The Jacobian determinant  $\det \mathbf{J}_\Phi$  is:

$$\begin{aligned}\det \mathbf{J}_\Phi &= r^2 (\cos^2 \phi \cos^2 \theta \sin \theta + \sin^3 \theta \sin^2 \phi + \sin^2 \phi \cos^2 \theta \sin \theta + \sin^3 \theta \cos^2 \phi) \\ &= r^2 (\cos^2 \theta \sin \theta (\cos^2 \phi + \sin^2 \phi) + \sin^3 \theta (\sin^2 \phi + \cos^2 \phi)) \\ &= r^2 \sin \theta (\sin^2 \theta + \cos^2 \theta) = r^2 \sin \theta\end{aligned}$$

If  $A \subset \mathbb{R}^3$  is an open, bounded set with definite volume and  $f : \mathbb{R}^3 \rightarrow \mathbb{R}$  is an integrable function, we convert between integration in Cartesian and spherical coordinates using the formula:

$$\begin{aligned}\iiint_{\Phi(A)} f(x, y, z) \, dx \, dy \, dz &= \\ \iiint_A f(r \sin \theta \cos \phi, r \sin \theta \sin \phi, r \cos \theta) \, r^2 \sin \theta \, dr \, d\theta \, d\phi\end{aligned}$$

## 2.6 Applications of Multiple Integration

For this subsection, let  $dV = dx \, dy \, dz$  be a differential volume element in  $\mathbb{R}^3$ .

### 2.6.1 Mass

Let  $Q \subset \mathbb{R}^3$  be a continuous 3-dimensional body in Euclidean space with an associated density  $\rho(x, y, z)$ . The mass  $M$  of the body  $Q$  is given by

$$M = \iiint_Q \rho(x, y, z) \, dV$$

### 2.6.2 Center of Mass

Let  $Q \subset \mathbb{R}^3$  be a continuous 3-dimensional body in Euclidean space with an associated density  $\rho(\mathbf{r})$  and total mass  $M$ . The center of mass  $\mathbf{r}^*$  of the body  $Q$  is given by:

$$\mathbf{r}^* = \frac{1}{M} \iiint_Q \rho(\mathbf{r}) \mathbf{r} \, dV$$

In terms of  $(x, y, z)$  components, if  $\mathbf{r}^* = (x^*, y^*, z^*)$  and density is given by  $\rho(x, y, z)$ , the center of mass is:

$$x^* = \frac{1}{M} \iiint_Q \rho(x, y, z) x \, dV$$

$$y^* = \frac{1}{M} \iiint_Q \rho(x, y, z) y \, dV$$

$$z^* = \frac{1}{M} \iiint_Q \rho(x, y, z) z \, dV$$

### 2.6.3 Moment of Inertia

Let  $Q \subset \mathbb{R}^3$  be a continuous 3-dimensional body in Euclidean space with an associated density  $\rho(\mathbf{r})$ . The moment of inertia  $I_a$  of body  $Q$  about a fixed axis of rotation  $a$  is given by:

$$I_a = \iiint_Q \rho(\mathbf{r}) \|\mathbf{d}(\mathbf{r})\|^2 \, dV$$

where

$$\mathbf{d}(\mathbf{r}) = \text{pr}_a^\perp(\mathbf{r})$$

is the orthogonal projection of the point  $\mathbf{r}$  onto the axis of rotation  $a$  and  $\|\mathbf{d}\|$  is the perpendicular distance from the axis of rotation to the point  $\mathbf{r}$ .

## 2.7 Improper Integrals in $\mathbb{R}^n$

The concern of this sub-section is to find a way to generalize the notion of improper integrals to integrals over arbitrary subsets of  $\mathbb{R}^n$ .

### 2.7.1 Review: Improper Integrals in $\mathbb{R}$

We consider two cases: an integral of an unbounded function on a bounded interval and the integral of a bounded function on an unbounded interval. The notions of the improper integral in these two cases are defined below.

1. Integral of an unbounded function on a bounded interval. Let  $a, b \in \mathbb{R}$  be two constants such that  $a < b$  and let  $g : (a, b] \rightarrow \mathbb{R}$  be unbounded at  $x = a$ , i.e.

$$\lim_{x \rightarrow a} g(x) = \infty$$

In this case, we define the improper integral:

$$\int_a^b g(x) \, dx = \lim_{\epsilon \rightarrow a} \int_\epsilon^b g(x) \, dx$$

provided the limit exists.

2. Integral of a bounded function on an unbounded interval. Let  $a \in \mathbb{R}$  be a constant and let  $g : [a, \infty) \rightarrow \mathbb{R}$  be a bounded function. In this case, we define the improper integral:

$$\int_a^\infty g(x) \, dx = \lim_{M \rightarrow \infty} \int_a^M g(x) \, dx$$

provided the limit exists.

### 2.7.2 Lemma: Improper Integral of a Bounded, Non-negative Function on an Unbounded Set

Let  $D \subset \mathbb{R}^n$  be an unbounded subset of  $\mathbb{R}^n$  and let  $f : D \rightarrow \mathbb{R}^+$  be a bounded, non-negative function, i.e.  $f(x) \geq 0$  for all  $x \in D$ . To define the improper integral of  $f$  on  $D$ , define the sequence of bounded sets  $D_j$  such that

$$D_j := D \cap [-j, j]^n \quad j \in \mathbb{N}$$

where  $[-j, j]^n$  is a hyper-rectangle in  $\mathbb{R}^n$ . More so, assume the sequence of integrals  $I_j$  given by:

$$I_j := \int_{D_j} f(x) \, dx$$

exists, noting that because  $f \geq 0$ ,  $I_1 \leq I_2 \leq I_3 \leq \dots$  and  $I_j$  is an increasing sequence. In this case, we define the improper integral of  $f$  over  $D$  using the sequence  $I_j$  with the relation:

$$\int_D f(x) \, dx := \lim_{j \rightarrow \infty} I_j$$

provided the limit exists.

### 2.7.3 Theorem: Improper Integral of a Bounded Function on an Unbounded Set

This theorem generalizes the previous lemma, which considered only non-negative functions. Let  $D \subset \mathbb{R}^n$  be an unbounded subset of  $\mathbb{R}^n$  and let  $f : D \rightarrow \mathbb{R}$  be a bounded function. To make use of the previous lemma, we split  $f$  into two non-negative functions  $f^+, f^- : D \rightarrow \mathbb{R}^+$  such that:

$$\begin{aligned} f^+ &:= \max(f, 0) \\ f^- &:= \max(-f, 0) = (-f)^+ \\ f &= f^+ - f^- \end{aligned}$$

Next, we apply the previous lemma to  $f^+$  and  $f^-$  separately. The definition for the improper integral of  $f$  over  $D$  that naturally follows is:

$$\int_D f(x) \, dx := \int_D f^+(x) \, dx - \int_D f^-(x) \, dx$$

provided the integrals of both  $f^+$  and  $f^-$  over  $D$  exist.

### 2.7.4 Note: Absolute Integrability On an Unbounded Set

Let  $D \subset \mathbb{R}^n$  be an unbounded subset of  $\mathbb{R}^n$  and define the function  $f : D \rightarrow \mathbb{R}$  such that the improper integral of  $f$  over  $D$

$$\int_D f(x) dx = \int_D f^+(x) dx - \int_D f^-(x) dx$$

exists. The functions  $f^+$  and  $f^-$  are defined above. In this case, the expression

$$\int_D f^+(x) dx + \int_D f^-(x) dx \in \mathbb{R}$$

also exists and is finite. More so,

$$\int_D f^+(x) dx + \int_D f^-(x) dx = \int_D |f(x)| dx \in \mathbb{R}$$

In this case, we say that  $f$  is absolutely integrable on  $D$ .

### 2.7.5 Example: An Identity for $\sqrt{\pi}$

Let  $I$  be the integral given by

$$I = \iint_{\mathbb{R}^2} e^{-(x^2+y^2)} dx dy$$

though a change of from Cartesian to polar coordinates, the integral becomes

$$\begin{aligned} I &= \int_0^{2\pi} \int_0^\infty e^{-r^2} r dr d\phi \\ &= 2\pi \int_0^\infty e^{-r^2} r dr \end{aligned}$$

through a change of variables  $u = r^2$  we obtain

$$I = \pi \int_0^\infty e^{-u} du = \pi \left( -e^{-u} \Big|_0^\infty \right) = \pi \tag{2.1}$$

On the other hand, in Cartesian coordinates, by applying the basic property of the exponential function  $e^a e^b = e^{a+b}$  we obtain

$$\begin{aligned} I &= \iint_{\mathbb{R}^2} e^{-x^2} e^{-y^2} dx dy = \int_{-\infty}^\infty \left( e^{-y^2} \int_{-\infty}^\infty e^{-x^2} dx \right) dy \\ &= \int_{-\infty}^\infty e^{-y^2} dy \int_{-\infty}^\infty e^{-x^2} dx \\ &= \left( \int_{-\infty}^\infty e^{-t^2} dt \right)^2 \end{aligned} \tag{2.2}$$

By equating Equations 2.1 and 2.2 we obtain

$$\begin{aligned} \left( \int_{-\infty}^\infty e^{-t^2} dt \right)^2 &= \pi \\ \int_{-\infty}^\infty e^{-t^2} dt &= \sqrt{\pi} \end{aligned}$$

**2.7.6 Lemma: Improper Integral of an Unbounded, Non-negative Function on a Bounded Set**

Let  $D \subset \mathbb{R}^n$  be a bounded subset of  $\mathbb{R}^n$  and let  $f : D \rightarrow \mathbb{R}^+ \cup \{\infty\}$  be an unbounded, non-negative function, i.e.  $f(x) \geq 0$  for all  $x \in D$ . To define the improper integral of  $f$  on  $D$ , define the sequence of bounded functions  $f_j$  such that:

$$f_j(x) = \begin{cases} f(x), & 0 \leq f(x) \leq j \\ j, & f(x) > j \end{cases}$$

noting that

$$f_1 \leq f_2 \leq \dots \leq \lim_{j \rightarrow \infty} f_j = f$$

is an increasing sequence of bounded functions. More so, assume the sequence of integrals  $I_j$  given by:

$$I_j := \int_D f_j(x) \, dx$$

exists, noting that because  $f \geq 0$ ,  $I_1 \leq I_2 \leq I_3 \leq \dots$  and  $I_j$  is an increasing sequence. In this case, we define the improper integral of  $f$  over  $D$  using the sequence  $I_j$  with the relation:

$$\int_D f(x) \, dx := \lim_{j \rightarrow \infty} I_j$$

provided the limit exists.

**2.7.7 Theorem: Improper Integral of a an Unbounded Function on a Bounded Set**

This theorem generalizes the previous lemma, which considered only non-negative functions. Let  $D \subset \mathbb{R}^n$  be a bounded subset of  $\mathbb{R}^n$  and let  $f : D \rightarrow \mathbb{R} \cup \{\pm\infty\}$  be an unbounded function. To make use of the previous lemma, we split  $f$  into two non-negative functions  $f^+, f^- : D \rightarrow \mathbb{R}^+$  such that:

$$\begin{aligned} f^+ &:= \max(f, 0) \\ f^- &:= \max(-f, 0) = (-f)^+ \\ f &= f^+ - f^- \end{aligned}$$

Next, we apply the previous lemma to  $f^+$  and  $f^-$  separately. The definition for the improper integral of  $f$  over  $D$  that naturally follows is:

$$\int_D f(x) \, dx := \int_D f^+(x) \, dx - \int_D f^-(x) \, dx$$

provided the integrals of both  $f^+$  and  $f^-$  over  $D$  exist.

**2.7.8 Note: Absolute Integrability of an Unbounded Function**

Let  $D \subset \mathbb{R}^n$  be a bounded subset of  $\mathbb{R}^n$  and let  $f : D \rightarrow \mathbb{R} \cup \{\pm\infty\}$  be an unbounded function such that the improper integral of  $f$  over  $D$

$$\int_D f(x) \, dx = \int_D f^+(x) \, dx - \int_D f^-(x) \, dx$$

exists. The functions  $f^+$  and  $f^-$  are defined above. In this case, the expression

$$\int_D f^+(x) \, dx + \int_D f^-(x) \, dx \in \mathbb{R}$$

also exists and is finite. More so,

$$\int_D f^+(x) \, dx + \int_D f^-(x) \, dx = \int_D |f(x)| \, dx \in \mathbb{R}$$

In this case, we say that  $f$  is absolutely integrable on  $D$ .

## 3 Curves and Surfaces in Space

### 3.1 Introduction to Curves in Space

A curve is the image of a continuous function from an interval (e.g.  $[a, b] \subset \mathbb{R}$ ) to a topological space (e.g.  $\mathbb{R}^n$ ). The function that defines the curve is called a parametrization.

#### 3.1.1 Definition: Curve and Parameterization

Let  $a, b \in \mathbb{R}$  be two real numbers such that  $a < b$ , let  $I = [a, b]$  be an interval in  $\mathbb{R}$ , and let  $\mathbf{r} : I \rightarrow \mathbb{R}^n$  be a continuous, vector-valued function mapping values in  $I$  to vectors in  $\mathbb{R}^n$ . The image  $\Gamma$  of  $\mathbf{r}$  given by  $\Gamma = \mathbf{r}(I)$  is a curve (or space curve) in  $\mathbb{R}^n$ . The function  $\mathbf{r}$  is a parameterization of the curve  $\Gamma$ .

#### 3.1.2 Definition: Smooth and Regular Curve

Let  $I \subset \mathbb{R}$  be a non-negative, real interval and let the continuous function  $\mathbf{r} : I \rightarrow \mathbb{R}^n$  be a parameterization of the curve  $\Gamma = \mathbf{r}(I)$ .

1. For the purpose of this text, we say that  $\mathbf{r}$  is smooth if  $\mathbf{r}$  is of differentiability class  $C^1$  i.e. if  $\mathbf{r}$ 's first derivative exists and is continuous for all  $t \in I$ . More generally, the smoothness of  $\mathbf{r}$  is characterized by its differentiability class  $C^n$ . Note the definition of smoothness is not universal; other texts often require  $\mathbf{r} \in C^n$  or  $\mathbf{r} \in C^\infty$  for  $\mathbf{r}$  to be smooth.
2. The function  $\mathbf{r}$  is regular if, in addition to being smooth,  $\dot{\mathbf{r}}(t) \neq \mathbf{0}$  or equivalently  $\|\dot{\mathbf{r}}(t)\| \neq 0$  for all  $t \in I$ .

#### 3.1.3 Length of a Curve

Let  $a, b \in \mathbb{R}$  be two real numbers such that  $a < b$ , let  $I = [a, b]$ , let  $\mathbf{r} : I \rightarrow \mathbb{R}^n$  be a smooth function and let  $\Gamma = \mathbf{r}(I)$  be a curve in  $\mathbb{R}^n$ . In this case, the length  $\ell$  of the curve  $\Gamma$  is given by:

$$\ell(\Gamma) := \int_a^b \|\dot{\mathbf{r}}(t)\| dt$$

#### 3.1.4 Theorem: Curve Length is Independent of Parameterization

The length of a curve  $\Gamma \subset \mathbb{R}^n$  is independent of the choice of parameterization (assuming the parameterization is regular).

More formally, if  $\Gamma \subset \mathbb{R}^n$  is a curve in  $\mathbb{R}^n$  and  $r : [a, b] \rightarrow \Gamma$  and  $\rho : [\alpha, \beta] \rightarrow \Gamma$  are two regular parameterizations of the same curve  $\Gamma$ , then:

$$\int_a^b \|\dot{r}(t)\| dt = \int_\alpha^\beta \|\dot{\rho}(t)\| dt$$

**Proof:** Because  $r$  and  $\rho$  are regular and parameterize the same curve, it follows that  $r(a) = \rho(\alpha)$  and  $r(b) = \rho(\beta)$ . More so, for each  $t \in [a, b]$  there exists  $\tau \in [\alpha, \beta]$  such that  $r(t) = \rho(\tau)$ . As a result, there exists a function  $\varphi : [\alpha, \beta] \rightarrow [a, b]$  such that  $\varphi(\tau) = t$  and

$$\rho(\tau) = r(\varphi(\tau))$$

Additionally, since the paths are regular, it follows that

$$\rho'(\tau) = (r(\varphi(\tau)))' = r'(\varphi(\tau))\varphi'(\tau)$$

where we use the chain rule for derivatives to get the second equality. Applying the definition of curve length, we see that

$$\ell(\Gamma) = \int_{\alpha}^{\beta} \|\rho'(\tau)\| \, d\tau = \int_{\alpha}^{\beta} \|r'(\varphi(\tau))\varphi'(\tau)\| \, d\tau \quad (3.1)$$

Note that  $\varphi$  is a scalar function. More so, because of the regularity of  $r$  and  $\rho$  it follows that  $\varphi$  is increasing on  $[\alpha, \beta]$ , so  $\varphi'(\tau)$  is positive for all  $\tau \in [\alpha, \beta]$ . As a result we can move  $\varphi'(\tau)$  out of the norm in Equation 3.1 to obtain:

$$\ell(\Gamma) = \int_{\alpha}^{\beta} \|r'(\varphi(\tau))\| \varphi'(\tau) \, d\tau \quad (3.2)$$

Next, we make the change of variables  $t = \varphi(\tau)$ ,  $dt = \varphi'(\tau) \, d\tau$ ,  $\varphi(\alpha) = a$ , and  $\varphi(\beta) = b$ . Plugging this change of variables into Equation 3.2 gives

$$\ell(\Gamma) = \int_{\alpha}^{\beta} \|r'(\varphi(\tau))\| \varphi'(\tau) \, d\tau = \int_a^b \|r'(t)\| \, dt \quad (3.3)$$

Comparing Equations 3.1 and 3.3 gives the equality

$$\int_{\alpha}^{\beta} \|\rho'(\tau)\| \, d\tau = \ell(\Gamma) = \int_a^b \|r'(t)\| \, dt$$

Since the choice of parameterizations  $r$  and  $\phi$  was arbitrary, it follows that the length of a curve is independent of parameterization.

### 3.1.5 Arc Length Parameterization

Let  $a, b \in \mathbb{R}$  be two real numbers such that  $a < b$ , let  $I = [a, b]$ , and let the function  $\mathbf{r} : I \rightarrow \mathbb{R}^n$  be a regular parameterization of the curve  $\Gamma = \mathbf{r}(I)$ . The *arc length parameter*  $s(t)$  of the curve  $\Gamma$  is defined to be:

$$s(t) := \int_a^t \|\mathbf{r}'(\tau)\| \, d\tau \quad \text{for } t \in [a, b]$$

and the parameterization  $\tilde{\mathbf{r}}(s) = \mathbf{r}(t(s))$ , where  $t(s)$  is the inverse of  $s(t)$ , is called the *arc length parameterization* of  $\Gamma$ . The arc length parameterization is useful because of the property:

$$\|\tilde{\mathbf{r}}'(s(t))\| = 1 \quad \forall \quad t \in [a, b]$$

meaning that the arc length parameterization  $\tilde{\mathbf{r}}$  traverses the curve  $\Gamma$  at unit speed.

## 3.2 Tangent, Normal, and Binormal Vectors

**Notation:** For the entirety of this subsection, let  $a, b \in \mathbb{R}$  be two real numbers such that  $a < b$ , let  $I = [a, b]$ , let the function  $\mathbf{r} : I \rightarrow \mathbb{R}^3$  be a regular parameterization of the curve  $\Gamma = \mathbf{r}(I)$  in terms of the general parameter  $t$  and let  $\mathbf{r}(s) = \mathbf{r}(t(s))$  be the arc length parameterization of  $\Gamma$ , where

$$s(t) = \int_0^t \|\mathbf{r}'(\tau)\| \, d\tau$$

is the arc length.



### 3.2.1 Definition: Unit Tangent Vector

The unit tangent vector (or simply tangent vector)  $\mathbf{T}$  to the curve  $\Gamma$  at  $t$  is the vector given by:

$$\mathbf{T}(t) = \frac{\dot{\mathbf{r}}(t)}{\|\dot{\mathbf{r}}(t)\|}$$

As the name implies, the tangent vector points tangent to the curve  $\Gamma$  at  $t$ .

### 3.2.2 Alternate Definition of the Tangent Vector

Because the general parameterization  $\mathbf{r}(t)$  and the arc length  $s$  are related by

$$\frac{d\mathbf{r}}{ds} = \frac{\dot{\mathbf{r}}}{\|\dot{\mathbf{r}}\|}$$

it follows that the tangent vector can be defined in terms of the arc length  $s$  as

$$\mathbf{T} = \frac{d\mathbf{r}}{ds} \quad \text{or more formally} \quad \mathbf{T}(s) = \frac{d[\mathbf{r}(t(s))]}{ds}$$

### 3.2.3 Definition: Unit Normal Vector

The unit normal vector (or simply normal vector)  $\mathbf{N}$  to the curve  $\Gamma$  at  $s$  is the unit vector given by:

$$\mathbf{N}(s) = \frac{\mathbf{T}'(s)}{\|\mathbf{T}'(s)\|}$$

where  $s$  is the arc-length parameter and  $\mathbf{T}'(s) = \frac{d\mathbf{T}}{ds}$ .

### 3.2.4 Note: Alternate Definition of the Normal Vector

The unit normal vector  $\mathbf{N}$  to the curve  $\Gamma$  at time  $t$  is also given in terms of the vector product:

$$\mathbf{N}(t) = \frac{\dot{\mathbf{r}}(t) \times (\dot{\mathbf{r}}(t) \times \ddot{\mathbf{r}}(t))}{\|\dot{\mathbf{r}}(t) \times (\dot{\mathbf{r}}(t) \times \ddot{\mathbf{r}}(t))\|}$$

Note that this formulation is valid for any parameter  $t$ , while the previous formula applied only to the arc length parameter  $s$ .

Additionally, we can define the unit normal vector  $\mathbf{N}$  in terms of the cross product

$$\mathbf{N}(t) = \mathbf{B}(t) \times \mathbf{T}(t)$$

### 3.2.5 Definition: Binormal Vector

The binormal vector  $\mathbf{B}$  is the unit vector defined as:

$$\mathbf{B} = \mathbf{T} \times \mathbf{N}$$

and the binormal vector to the curve  $\Gamma$  at  $t$  is given by

$$\mathbf{B}(t) = \mathbf{T}(t) \times \mathbf{N}(t)$$

### 3.2.6 Note: Alternate Definition of the Binormal Vector

The binormal vector  $\mathbf{B}$  to the curve  $\Gamma$  at time  $t$  is also given by the vector product:

$$\mathbf{B}(t) = \frac{\dot{\mathbf{r}}(t) \times \ddot{\mathbf{r}}(t)}{\|\dot{\mathbf{r}}(t) \times \ddot{\mathbf{r}}(t)\|}$$

This formulation is valid for any parameter  $t$ , not just for the arc length parameter  $s$ .

### 3.2.7 Definition: Normal Plane

Let  $a, b \in \mathbb{R}$  be two real numbers such that  $a < b$ , let  $I = [a, b]$ , and let the function  $\mathbf{r} : I \rightarrow \mathbb{R}^3$  be a regular parameterization of the curve  $\Gamma = \mathbf{r}(I)$ . In this case, the normal plane to  $\Gamma$  at the point  $\mathbf{r}(t)$  is the plane through  $\mathbf{r}(t)$  that is perpendicular to the tangent vector  $\mathbf{T}(t)$ . Equivalently, the normal plane is the set of all points  $\mathbf{p} = (x, y, z)$  such that:

$$(\mathbf{p} - \mathbf{r}(t)) \cdot \mathbf{T}(t) = 0$$

It follows that the normal plane at  $\mathbf{r}(t)$  is the plane containing both  $\mathbf{N}(t)$  and  $\mathbf{B}(t)$ .

### 3.2.8 Definition: Osculating Plane

Let  $a, b \in \mathbb{R}$  be two real numbers such that  $a < b$ , let  $I = [a, b]$ , and let the function  $\mathbf{r} : I \rightarrow \mathbb{R}^3$  be a regular parameterization of the curve  $\Gamma = \mathbf{r}(I)$ . In this case, the osculating plane to  $\Gamma$  at the point  $\mathbf{r}(t)$  is the plane through  $\mathbf{r}(t)$  that is perpendicular to the binormal vector  $\mathbf{B}(t)$ . Equivalently, the osculating plane is the set of all points  $\mathbf{p} = (x, y, z)$  such that:

$$(\mathbf{p} - \mathbf{r}(t)) \cdot \mathbf{B}(t) = 0$$

It follows that the osculating plane at  $\mathbf{r}(t)$  is the plane containing both  $\mathbf{T}(t)$  and  $\mathbf{N}(t)$ .

### 3.2.9 Frenet-Serret Frame

Let  $\Gamma$  be a curve in  $\mathbb{R}^3$  and let  $\mathbf{r} : [a, b] \rightarrow \mathbb{R}^3$  be a regular parameterization of  $\Gamma$ . The triad of vectors  $(\mathbf{T}, \mathbf{N}, \mathbf{B})$  (i.e. the unit tangent, normal, and binormal vectors to the curve  $\Gamma$  at a point  $\mathbf{r}(t)$ ) are called the *TNB* or *Frenet-Serret frame* of the curve  $\Gamma$  at the point  $\mathbf{r}(t)$ . The TNB frame at any point  $\mathbf{r}(t)$  forms an orthonormal basis of the Euclidean space  $\mathbb{R}^3$ .

## 3.3 Curvature

**Notation:** For the entirety of this subsection, let  $a, b \in \mathbb{R}$  be two real numbers such that  $a < b$ , let  $I = [a, b]$ , let the function  $\mathbf{r} : I \rightarrow \mathbb{R}^3$  be a regular parameterization of the curve  $\Gamma = \mathbf{r}(I)$  in terms of the general parameter  $t$  and let  $\mathbf{r}(s) = \mathbf{r}(t(s))$  be the arc length parameterization of  $\Gamma$ , where

$$s(t) = \int_0^t \|\mathbf{r}'(\tau)\| d\tau$$

is the arc length.

### 3.3.1 Curvature in Terms of Arc Length Parameter and Acceleration

The curvature of a space curve at a point on the curve equals the *magnitude of the acceleration* of a particle moving along the curve at unit speed at that point. Because the definition requires unit speed, we often describe curvature in terms of the arc length parameter  $s$ , which results in traversal of a curve at unit speed.

If  $\Gamma$  is a space curve and  $\mathbf{r}(s)$  is the arc length parameterization, the acceleration of the curve is given by  $\mathbf{r}''(s)$ , and the curvature at  $s$  is given by

$$\kappa(s) = \|\mathbf{r}''(s)\|$$

This expression applies only if the curve  $\Gamma$  is parameterized in terms of the arc length parameter  $s$ .

### 3.3.2 Curvature in Terms Arc Length Parameter and Tangent Vector

For a arc length parameterization, the unit tangent vector  $\mathbf{T}(s)$  is given by  $\mathbf{r}'(s)$ , the acceleration  $\mathbf{r}''(s)$  is given by  $\mathbf{T}'(s)$ , and the curvature at  $s$  in terms of the tangent vector is given by

$$\kappa(s) = \|\mathbf{r}''(s)\| = \|\mathbf{T}'(s)\|$$

Once again, this expression applies only if the curve  $\Gamma$  is parameterized in terms of the arc length parameter  $s$ .

### 3.3.3 Curvature in Terms of General Parameter

In terms of the general parameter  $t$ , the curvature  $\kappa$  of the curve  $\Gamma$  at  $t$  is given by

$$\kappa(t) = \frac{\|\dot{\mathbf{r}}(t) \times \ddot{\mathbf{r}}(t)\|}{\|\dot{\mathbf{r}}(t)\|^3}$$

where  $\dot{\mathbf{r}}$  denotes differentiation with respect to the general parameter  $t$ . This formulation of curvature applies to any choice of parameter, while the previous one is valid only for the arc length parameter  $s$ .

### 3.3.4 Radius of Curvature

The radius of curvature  $\rho$  of the curve  $\Gamma$  at  $s$  is given by

$$\rho = \frac{1}{\kappa}$$

where  $\kappa(s)$  is the curvature of the curve  $\Gamma$  at  $s$ . The radius of curvature is equal to the radius of the osculating circle at  $s$ .

### 3.3.5 Curvature in Terms of General Parameter and Tangent Vector

For a general parameterization  $\mathbf{r}(t)$  of the curve  $\Gamma$ , we can describe the curvature on a curve at  $t$  in terms of the tangent vector  $\mathbf{T}$  with the formula:

$$\kappa(t) = \frac{\|\dot{\mathbf{T}}(t)\|}{\|\dot{\mathbf{r}}(t)\|}$$

This formulation of curvature applies to any choice of parameter  $t$ . Incidentally, it follows that

$$\frac{\|\dot{\mathbf{T}}(t)\|}{\|\dot{\mathbf{r}}(t)\|} = \frac{\|\dot{\mathbf{r}}(t) \times \ddot{\mathbf{r}}(t)\|}{\|\dot{\mathbf{r}}(t)\|^3}$$

### 3.3.6 Relationship Between Curvature, $\mathbf{T}'$ , and $\mathbf{N}$

Curvature  $\kappa$  is related to the tangent vector  $\mathbf{T}$  and normal vector  $\mathbf{N}$  by the relationship:

$$\mathbf{T}' = \kappa\mathbf{N}$$

Where  $\mathbf{T}'$  denotes differentiation with respect to the arc length parameter  $s$ .

More thoroughly, if  $\mathbf{r}(s)$  is the arc length parameterization of the curve  $\Gamma$ , then the acceleration  $\mathbf{r}''(s) = \mathbf{T}'(s)$  at  $s$  is related to the normal vector  $\mathbf{N}(s)$  at  $s$  by the relationship

$$\mathbf{T}'(s) = \kappa(s)\mathbf{N}(s)$$

where  $\kappa(s)$  is the curvature of the curve  $\Gamma$  at  $s$ .

### 3.3.7 Note: Geometric Interpretation of Zero Curvature

If the curvature  $\kappa$  equals zero for all points on a curve, then  $\mathbf{T}'(s) = 0$  and the tangent to the curve is constant, meaning the curve is a straight line.

$$\kappa = 0 \text{ for all points on } \Gamma \iff \Gamma \text{ is a straight line}$$

## 3.4 Torsion

The torsion of a curve describes how sharply the curve twists out of the plane of curvature. In this respect, torsion gives a sense of how three-dimensional a plane curve is.

### 3.4.1 Relationship Between Torsion, $\mathbf{B}'$ , and $\mathbf{N}$

Torsion  $\tau$  is related to the binormal vector  $\mathbf{B}$  and normal vector  $\mathbf{N}$  by the relationship:

$$\mathbf{B}' = -\tau\mathbf{N}$$

Where  $\mathbf{B}'$  denotes differentiation with respect to the arc length parameter  $s$ .

More thoroughly, if  $\mathbf{r}(s)$  is the arc length parameterization of the curve  $\Gamma$ , then the derivative of the binormal vector  $\mathbf{B}'(s)$  at  $s$  is related to the normal vector  $\mathbf{N}(s)$  at  $s$  by the relationship

$$\mathbf{B}'(s) = \tau(s)\mathbf{N}(s)$$

where  $\tau(s)$  is the torsion of the curve  $\Gamma$  at  $s$ .

### 3.4.2 Note: Geometric Interpretation of Zero Torsion

If the curvature  $\tau$  equals zero for all points on a curve, then  $\mathbf{B}'(s) = 0$  and the binormal to the curve is constant, meaning the curve is two-dimensional and contained in a single plane.

$$\tau = 0 \text{ for all points on } \Gamma \iff \Gamma \text{ is a plane curve}$$

### 3.4.3 Formula for Torsion in Terms of Arc Length Parameter

If  $\mathbf{r}(s)$  is the arc length parameterization of a space curve  $\Gamma$ , we describe the torsion  $\tau$  of  $\Gamma$  at  $s$  with the formula:

$$\tau(s) = \frac{[\mathbf{r}'(s), \mathbf{r}''(s), \mathbf{r}'''(s)]}{\|\mathbf{r}''(s)\|^2} = \frac{(\mathbf{r}'(s) \times \mathbf{r}''(s)) \cdot \mathbf{r}'''(s)}{\kappa^2}$$

where we have used the definition of curvature  $\kappa = \|\mathbf{r}''(s)\|$  and  $[\mathbf{r}'(s), \mathbf{r}''(s), \mathbf{r}'''(s)]$  denotes the scalar triple product operation. Note that this formula applies only to an arc length parameterization  $\mathbf{r}(s)$ .

### 3.4.4 Formula for Torsion in Terms of General Parameter

If  $\mathbf{r}(t)$  is a general parameterization of a space curve  $\Gamma$ , we describe the torsion  $\tau$  of  $\Gamma$  at  $t$  with the formula:

$$\tau(t) = \frac{[\dot{\mathbf{r}}(t), \ddot{\mathbf{r}}(t), \dddot{\mathbf{r}}(t)]}{\|\dot{\mathbf{r}}(t) \times \ddot{\mathbf{r}}(t)\|^2} = \frac{(\dot{\mathbf{r}}(t) \times \ddot{\mathbf{r}}(t)) \cdot \dddot{\mathbf{r}}(t)}{\|\dot{\mathbf{r}}(t) \times \ddot{\mathbf{r}}(t)\|^2}$$

where  $[\dot{\mathbf{r}}(t), \ddot{\mathbf{r}}(t), \dddot{\mathbf{r}}(t)]$  denotes the scalar triple product operation. Note that this formula holds for any parameter  $t$ , while the previous one applies only to the arc length parameter  $s$ .

## 3.5 Frenet-Serret Formulae

The Frenet-Serret formulas succinctly relate the  $\mathbf{T}$ ,  $\mathbf{N}$ , and  $\mathbf{B}$  vectors to the curvature  $\kappa$  and torsion  $\tau$  of a curve.

Let  $\mathbf{r}(s)$  be the arc length parameterization of a space curve  $\Gamma$ . In terms of  $s$ , the Frenet-Serret formulas are:

$$\begin{aligned}\mathbf{T}' &= \kappa\mathbf{N} \\ \mathbf{N}' &= -\kappa\mathbf{T} + \tau\mathbf{B} \\ \mathbf{B}' &= -\tau\mathbf{N}\end{aligned}$$

where  $'$  denotes differentiation with respect to the arc length parameter  $s$ . In this form, the formulas hold only for the arc length parameterization  $\mathbf{r}(s)$ .

### 3.5.1 Matrix Form of the Frenet-Serret Formulas

In matrix form, the Frenet-Serret formulas are:

$$\begin{bmatrix} \mathbf{T}' \\ \mathbf{N}' \\ \mathbf{B}' \end{bmatrix} = \begin{bmatrix} 0 & \kappa & 0 \\ -\kappa & 0 & \tau \\ 0 & -\tau & 0 \end{bmatrix} \begin{bmatrix} \mathbf{T} \\ \mathbf{N} \\ \mathbf{B} \end{bmatrix}$$

Once again,  $'$  denotes differentiation with respect to the arc length parameter  $s$ , and the formulas in this form hold only for the arc length parameterization  $\mathbf{r}(s)$ .

### 3.5.2 Frenet-Serret Formulas in Terms of General Parameter

In terms of a general parameterization  $\mathbf{r}(t)$ , the Frenet-Serret formulas are:

$$\frac{d}{dt} \begin{bmatrix} \mathbf{T} \\ \mathbf{N} \\ \mathbf{B} \end{bmatrix} = \begin{bmatrix} \dot{\mathbf{T}} \\ \dot{\mathbf{N}} \\ \dot{\mathbf{B}} \end{bmatrix} = \|\mathbf{r}'(t)\| \begin{bmatrix} 0 & \kappa & 0 \\ -\kappa & 0 & \tau \\ 0 & -\tau & 0 \end{bmatrix} \begin{bmatrix} \mathbf{T} \\ \mathbf{N} \\ \mathbf{B} \end{bmatrix}$$

where the extra factor  $\|\mathbf{r}'(t)\|$  results because of the change of variables from  $s$  to  $t$ .

## 3.6 Surfaces in Euclidean Space

Throughout this section, unless otherwise stated, the word surface is taken to be a surface in Euclidean space  $\mathbb{R}^3$ . Surfaces may be given in explicit, implicit, and parametric form, with implicit and parametric form being most popular.

### 3.6.1 Explicitly Defined Surface

In explicit form, a surface is the graph of a continuous scalar function of two variables defined on a connected subset of  $\mathbb{R}^2$ . More formally, if  $D \subset \mathbb{R}^2$  is a connected subset of  $\mathbb{R}^2$  and  $f : D \rightarrow \mathbb{R}$  is a continuous function, then the graph of  $f$

$$\mathcal{G}(f) = \{(x, y, z) \mid (x, y) \in D, z = f(x, y)\}$$

is an explicitly defined surface.

### 3.6.2 Implicitly Defined Surface

An implicit surface is the set of all zeros of a continuously differentiable scalar function of three variables. More formally, let  $\Omega \subset \mathbb{R}^3$  be a subset of  $\mathbb{R}^3$  and let  $f : \Omega \rightarrow \mathbb{R}$  be a continuously differentiable function such that  $\nabla f \neq 0$  for all  $(x, y, z) \in \Omega$  (i.e. the gradient of  $f$  given by  $\nabla f = (f_x, f_y, f_z)$ ) is nonzero over  $f$ 's domain. In this case, the set  $\mathcal{S}$  of all points satisfying the equation  $f(x, y, z) = 0$ , given by:

$$\mathcal{S} = \{(x, y, z) \mid f(x, y, z) = 0\}$$

is an implicitly defined surface.

### 3.6.3 Parametric Surface

Let  $D \subset \mathbb{R}^2$  be a connected surface in  $\mathbb{R}^2$ , and let  $\mathbf{r} : D \rightarrow \mathbb{R}^3$  be a continuously differentiable vector function (i.e.  $\mathbf{r} \in C^1$ ) with scalar components  $\mathbf{r}(u, v) = (r_1(u, v), r_2(u, v), r_3(u, v))$ . More so, let

$$\mathbf{r}_u(u, v) \times \mathbf{r}_v(u, v) \neq 0$$

for all points  $(u, v) \in D$ . This is equivalent to requiring that the Jacobian matrix

$$\mathbf{J}_{\mathbf{r}}(u, v) = \begin{bmatrix} \frac{\partial r_1}{\partial u} & \frac{\partial r_1}{\partial v} \\ \frac{\partial r_2}{\partial u} & \frac{\partial r_2}{\partial v} \\ \frac{\partial r_3}{\partial u} & \frac{\partial r_3}{\partial v} \end{bmatrix}$$

has rank 2 (maximum rank for a  $3 \times 2$  matrix) for all  $(u, v) \in D$  i.e.

$$\text{rank}(\mathbf{J}_{\mathbf{r}}(u, v)) = 2 \quad \forall (u, v) \in D$$

In this case, the set

$$\mathcal{S} = \{\mathbf{r}(u, v) \mid (u, v) \in D\}$$

is a parametrically defined surface.

### 3.6.4 Normal Vector to a Parametric Surface

The normal vector  $\mathbf{n}$  to a parametric surface  $\mathcal{S}$  parameterized by the vector function  $\mathbf{r} : \mathbb{R}^2 \rightarrow \mathbb{R}^3$  mapping  $(u, v) \mapsto \mathbf{r}(u, v)$  at the point  $\mathbf{r}_0 = \mathbf{r}(u_0, v_0)$  is

$$\mathbf{n}(u_0, v_0) = \mathbf{r}_u(u_0, v_0) \times \mathbf{r}_v(u_0, v_0)$$

where  $\mathbf{r}_u$  and  $\mathbf{r}_v$  are  $\mathbf{r}$ 's partial derivatives with respect to  $u$  and  $v$ , respectively.

### 3.6.5 Tangent Plane of a Parametric Surface

The tangent plane  $\mathcal{T}$  to a parametric surface  $\mathcal{S}$  parameterized by the vector function  $\mathbf{r} : \mathbb{R}^2 \rightarrow \mathbb{R}^3$  mapping  $(u, v) \mapsto \mathbf{r}(u, v)$  at the point  $\mathbf{r}_0 = \mathbf{r}(u_0, v_0)$  is the set of all points  $\mathbf{p} = (x, y, z)$  satisfying the equation:

$$(\mathbf{p} - \mathbf{r}_0) \cdot (\mathbf{r}_u \times \mathbf{r}_v) = 0$$

where  $\mathbf{r}_u$  and  $\mathbf{r}_v$  are  $\mathbf{r}$ 's partial derivatives with respect to  $u$  and  $v$ , respectively, evaluated at  $(u_0, v_0)$ . We can write the equation for  $\mathcal{T}$  at  $(u_0, v_0)$  more thoroughly as:

$$\mathcal{T} = \{(x, y, z) \in \mathbb{R}^3 \mid ((x, y, z) - \mathbf{r}(u_0, v_0)) \cdot (\mathbf{r}_u(u_0, v_0) \times \mathbf{r}_v(u_0, v_0)) = 0\}$$

### 3.6.6 Tangent Plane of an Implicit Surface

Let  $\Omega \subset \mathbb{R}^3$  be a subset of  $\mathbb{R}^3$ , let  $f : \Omega \rightarrow \mathbb{R}$  be a continuously differentiable function such that  $\nabla f \neq 0$  for all  $(x, y, z) \in \Omega$ , and let  $\mathcal{S}$  be the implicit surface given as the solution set of the equation  $f(x, y, z) = 0$ , i.e.

$$\mathcal{S} = \{(x, y, z) \in \mathbb{R}^3 \mid f(x, y, z) = 0\}$$

In this case, the equation of the tangent plane  $\mathcal{T}$  of the surface  $\mathcal{S}$  at the point  $\mathbf{r}_0 = (x_0, y_0, z_0)$  is the set of all points  $\mathbf{p} = (x, y, z)$  satisfying the equation

$$(\mathbf{p} - \mathbf{r}_0) \cdot \nabla f(\mathbf{r}_0) = 0$$

where  $\nabla f(\mathbf{r}_0)$  denotes the gradient of  $f$  evaluated at  $\mathbf{r}_0 = (x_0, y_0, z_0)$ . We can write the equation for  $\mathcal{T}$  at  $(x_0, y_0, z_0)$  more thoroughly as:

$$\mathcal{T} = \{(x, y, z) \in \mathbb{R}^3 \mid ((x, y, z) - (x_0, y_0, z_0)) \cdot \nabla f(x_0, y_0, z_0) = 0\}$$

## 3.7 Surfaces of Revolution

Surfaces of revolution are surfaces formed by rotating a curve around an axis of revolution in Euclidean space. This section considers only the simple case of a plane curve in the  $xz$  plane rotated about the  $z$ -axis.

### 3.7.1 Matrix for Rotation About the $z$ -Axis

Rotation of a vector in the  $xz$  plane about the  $z$ -axis through an angle  $\varphi$  in  $\mathbb{R}^3$  is a linear transformation described by the matrix  $R_\varphi$

$$R_\varphi = \begin{bmatrix} \cos \varphi & -\sin \varphi & 0 \\ \sin \varphi & \cos \varphi & 0 \\ 0 & 0 & 1 \end{bmatrix}$$

### 3.7.2 Parametrization of a Surface of Rotation

A surface of rotation formed by rotating a plane curve in the  $xz$  plane about the  $z$  axis may be parameterized with the parameters by the function  $\mathbf{r} : \mathbb{R}^2 \rightarrow \mathbb{R}^3$  mapping  $(t, \phi) \mapsto \mathbf{r}(t, \phi)$ , where  $I \subset \mathbb{R}$  is an interval in  $\mathbb{R}$ ,  $t \in I$ ,  $\varphi \in [0, 2\pi)$ , and  $\mathbf{r}$  is given by:

$$\mathbf{r}(t, \phi) = R_\varphi (x(t), y(t), z(t))^T = \begin{bmatrix} \cos \varphi & -\sin \varphi & 0 \\ \sin \varphi & \cos \varphi & 0 \\ 0 & 0 & 1 \end{bmatrix} \begin{bmatrix} x(t) \\ 0 \\ z(t) \end{bmatrix}$$

where  $y(t) \equiv 0$  because the curve is in the  $xz$  plane.

### 3.7.3 Parameterization of Common Surfaces of Revolution

1. A cylinder of radius  $a$  whose  $z$  coordinate ranges from  $\alpha$  to  $\beta$  is described by the parameters  $z$  and polar angle  $\varphi$ . The parameterization  $\mathbf{r}(z, \varphi)$  is:

$$\mathbf{r}(z, \varphi) = \begin{bmatrix} a \cos \varphi \\ a \sin \varphi \\ z \end{bmatrix}$$

where  $z \in [\alpha, \beta]$  and  $\varphi \in [0, 2\pi)$ .

2. A cone of radius  $R$  and height  $h$  is parameterized by the  $x$  coordinate  $x$  and the polar angle  $\varphi$ . The parameterization  $\mathbf{r}(x, \varphi)$  is:

$$\mathbf{r}(x, \varphi) = \begin{bmatrix} x \cos \varphi \\ x \sin \varphi \\ h \left(1 - \frac{x}{R}\right) \end{bmatrix}$$

where  $x \in [0, R]$  and  $\varphi \in [0, 2\pi)$ .

## 3.8 Area of Surfaces

### 3.8.1 Definition of Surface Area in Euclidean Space

Let  $D \subset \mathbb{R}^2$  be a connected subset of  $\mathbb{R}^2$  and let  $\mathbf{r} : D \rightarrow \mathbb{R}^3$  mapping  $(u, v) \mapsto \mathbf{r}(u, v)$  be a continuously differentiable vector function parametrizing the surface  $\mathcal{S}$ . In this case, the area  $A$  of the surface  $\mathcal{S}$  is defined as:

$$A(\mathcal{S}) := \iint_D \|\mathbf{r}_u \times \mathbf{r}_v\| \, du \, dv$$

where  $\mathbf{r}_u$  and  $\mathbf{r}_v$  are  $\mathbf{r}$ 's partial derivatives with respect to  $u$  and  $v$ , respectively.

### 3.8.2 Alternate Formulation of Area of a Surface

By applying the vector identity

$$\|\mathbf{r}_u \times \mathbf{r}_v\|^2 = \|\mathbf{r}_u\|^2 \|\mathbf{r}_v\|^2 - (\mathbf{r}_u \cdot \mathbf{r}_v)^2$$

to the definition of the area of the surface  $\mathcal{S}$ , we obtain can obtain the alternate formulation

$$A(\mathcal{S}) = \iint_D \sqrt{\|\mathbf{r}_u\|^2 \|\mathbf{r}_v\|^2 - (\mathbf{r}_u \cdot \mathbf{r}_v)^2} \, du \, dv$$

### 3.8.3 Theorem: Surface Area is Independent of Parameterization

The area of a surface is independent of the surface's parameterization.

More formally, if  $\mathcal{S}$  is a surface in Euclidean space,  $D, \Delta \subset \mathbb{R}^2$  are connected subsets of  $\mathbb{R}^2$ , and the continuously differentiable vector functions  $\mathbf{r} : D \rightarrow \mathbb{R}^3$  mapping  $(u, v) \mapsto \mathbf{r}(u, v)$  and  $\boldsymbol{\rho} : \Delta \rightarrow \mathbb{R}^3$  mapping  $(\mu, \nu) \mapsto \boldsymbol{\rho}(\mu, \nu)$  are two parameterizations of  $\mathcal{S}$ , then

$$\iint_D \sqrt{\|\mathbf{r}_u\|^2 \|\mathbf{r}_v\|^2 - (\mathbf{r}_u \cdot \mathbf{r}_v)^2} \, du \, dv = \iint_\Delta \sqrt{\|\boldsymbol{\rho}_\mu\|^2 \|\boldsymbol{\rho}_\nu\|^2 - (\boldsymbol{\rho}_\mu \cdot \boldsymbol{\rho}_\nu)^2} \, d\mu \, d\nu$$



**Proof:** Let  $\Phi : \Delta \rightarrow D$  be a bijective mapping between the sets  $D$  and  $\Delta$ , so that the functions  $\mathbf{r}$  and  $\boldsymbol{\rho}$  are related by the composition  $\boldsymbol{\rho} = \mathbf{r} \circ \Phi$ , written more formally as

$$\boldsymbol{\rho}(\mu, \nu) = \mathbf{r}(\Phi(\mu, \nu))$$

The function  $\Phi$  may be written in terms of the scalar components  $U$  and  $(\mu, \nu)$  where:

$$\Phi(\mu, \nu) = (U(\mu, \nu), V(\mu, \nu))$$

In terms of the scalar components  $U$  and  $V$ , the function  $\boldsymbol{\rho}$  becomes

$$\boldsymbol{\rho}(\mu, \nu) = \mathbf{r}(U(\mu, \nu), V(\mu, \nu))$$

. Using the chain rule for the derivative of a composition, we calculate  $\boldsymbol{\rho}$ 's partial derivatives  $\boldsymbol{\rho}_\mu$  and  $\boldsymbol{\rho}_\nu$  to be:

$$\begin{aligned}\boldsymbol{\rho}_\mu &= \mathbf{r}_u U_\mu + \mathbf{r}_v V_\mu \\ \boldsymbol{\rho}_\nu &= \mathbf{r}_u U_\nu + \mathbf{r}_v V_\nu\end{aligned}$$

Next, we calculate the vector product

$$\begin{aligned}\boldsymbol{\rho}_\mu \times \boldsymbol{\rho}_\nu &= (\mathbf{r}_u U_\mu + \mathbf{r}_v V_\mu) \times (\mathbf{r}_u U_\nu + \mathbf{r}_v V_\nu) \\ &= \mathbf{r}_u \times \mathbf{r}_v (U_\mu V_\nu - V_\mu U_\nu)\end{aligned}$$

Next, taking the norm of both sides gives:

$$\|\boldsymbol{\rho}_\mu \times \boldsymbol{\rho}_\nu\| = \|\mathbf{r}_u \times \mathbf{r}_v\| (U_\mu V_\nu - V_\mu U_\nu)$$

in which we recognize that the term  $(U_\mu V_\nu - V_\mu U_\nu)$  to be the determinant of the Jacobian matrix

$$\mathbf{J}_\Phi = \begin{bmatrix} U_\mu & U_\nu \\ V_\mu & V_\nu \end{bmatrix}$$

encoding the change of coordinates between  $(u, v)$  and  $(\mu, \nu)$ . From the equality:

$$\|\boldsymbol{\rho}_\mu \times \boldsymbol{\rho}_\nu\| = \|\mathbf{r}_u \times \mathbf{r}_v\| \det \mathbf{J}_\Phi(\mu, \nu)$$

and Theorem 2.4.11 describing the change of coordinates during multiple integration, it follows that

$$\begin{aligned}A(\mathcal{S}) &= \iint_D \sqrt{\|\mathbf{r}_u\|^2 \|\mathbf{r}_v\|^2 - (\mathbf{r}_u \cdot \mathbf{r}_v)^2} \, du \, dv \\ &= \iint_\Delta \sqrt{\|\boldsymbol{\rho}_\mu\|^2 \|\boldsymbol{\rho}_\nu\|^2 - (\boldsymbol{\rho}_\mu \cdot \boldsymbol{\rho}_\nu)^2} \, d\mu \, d\nu = A(\mathcal{S})\end{aligned}$$

Since the parameterizations  $\mathbf{r}$  and  $\boldsymbol{\rho}$  were arbitrary, it follows that surface area is independent of parameterization.

## 4 Vector Analysis

### 4.1 Line Integrals

A line integral is an integral of a function (or field) evaluated along a curve.

#### 4.1.1 Line Integral of a Scalar Field

Let  $I = [a, b] \subset \mathbb{R}$  be an interval and let  $\mathbf{r} : I \rightarrow \mathbb{R}^n$  be a smooth parameterization of the curve  $\Gamma$ . More so, let  $f : \mathbb{R}^n \rightarrow \mathbb{R}$  be a scalar field. In this case, the line integral of  $f$  on  $\Gamma$  is:

$$\int_{\Gamma} f(\mathbf{r}) \, ds = \int_a^b f(\mathbf{r}(t)) \|\mathbf{r}'(t)\| \, dt$$

#### 4.1.2 Proposition: Line Integral of a Scalar Field is Independent of Parameterization

The integral of a scalar field  $f$  along a curve is independent of the curve's parameterization.

More formally, let  $f : \mathbb{R}^n \rightarrow \mathbb{R}$  be a scalar field and let  $\Gamma \subset \mathbb{R}^n$  be a space curve. More so, let  $I = [a, b]$  and  $J = [\alpha, \beta]$  be connected intervals in  $\mathbb{R}$ , and let the smooth functions  $\mathbf{r} : I \rightarrow \Gamma$  mapping  $t \mapsto \mathbf{r}(t)$  and  $\boldsymbol{\rho} : J \rightarrow \Gamma$  mapping  $\tau \mapsto \boldsymbol{\rho}(\tau)$  be two arbitrary parameterizations of  $\Gamma$ . In this case:

$$\int_{\Gamma} f(\mathbf{r}) \, ds = \int_a^b f(\mathbf{r}(t)) \|\mathbf{r}'(t)\| \, dt = \int_{\alpha}^{\beta} f(\boldsymbol{\rho}(\tau)) \|\boldsymbol{\rho}'(\tau)\| \, d\tau = \int_{\Gamma} f(\boldsymbol{\rho}) \, ds$$

#### 4.1.3 Line Integral of a Vector Field

Let  $I = [a, b] \subset \mathbb{R}$  be an connected interval and let  $\mathbf{r} : I \rightarrow \mathbb{R}^n$  be a smooth parameterization of the curve  $\Gamma$ . More so, let  $\mathbf{F} : \mathbb{R}^n \rightarrow \mathbb{R}^n$  be a vector field. In this case, the line integral of  $\mathbf{F}$  on  $\Gamma$  is:

$$\int_{\Gamma} \mathbf{F}(\mathbf{r}) \cdot d\mathbf{r} = \int_a^b \mathbf{F}(\mathbf{r}(t)) \cdot \mathbf{r}'(t) \, dt$$

#### 4.1.4 Proposition: Line Integral of a Vector Field is Independent of Parameterization

The integral of a vector field  $\mathbf{F}$  along a curve is independent of the curve's parameterization.

More formally, let  $\mathbf{F} : \mathbb{R}^n \rightarrow \mathbb{R}^n$  be a vector field and let  $\Gamma \subset \mathbb{R}^n$  be a space curve. More so, let  $I = [a, b]$  and  $J = [\alpha, \beta]$  be connected intervals in  $\mathbb{R}$ , and let the smooth functions  $\mathbf{r} : I \rightarrow \Gamma$  mapping  $t \mapsto \mathbf{r}(t)$  and  $\boldsymbol{\rho} : J \rightarrow \Gamma$  mapping  $\tau \mapsto \boldsymbol{\rho}(\tau)$  be two arbitrary parameterizations of  $\Gamma$ . In this case:

$$\int_{\Gamma} \mathbf{F}(\mathbf{r}) \cdot d\mathbf{r} = \int_a^b \mathbf{F}(\mathbf{r}(t)) \cdot \mathbf{r}'(t) \, dt = \int_{\alpha}^{\beta} \mathbf{F}(\boldsymbol{\rho}(\tau)) \cdot \boldsymbol{\rho}'(\tau) \, d\tau = \int_{\Gamma} \mathbf{F}(\boldsymbol{\rho}) \cdot d\boldsymbol{\rho}$$

#### 4.1.5 Proposition: Line Integral of a Vector Field and Orientation

Changing the orientation of a curve over which we evaluate the line integral of a vector field changes the sign of the integral.

More formally, let  $\mathbf{F} : \mathbb{R}^n \rightarrow \mathbb{R}^n$  be a vector field, let  $I = [a, b]$  be a connected interval in  $\mathbb{R}$ , and let the smooth function  $\mathbf{r} : I \rightarrow \mathbb{R}^n$  parameterize the curve  $\Gamma \subset \mathbb{R}^n$ . Finally, let  $\Gamma_-$  be the same curve  $\Gamma$ , but with opposite orientation. In this case

$$\int_{\Gamma_-} \mathbf{F}(\mathbf{r}) \cdot d\mathbf{r} = - \int_{\Gamma} \mathbf{F}(\mathbf{r}) \cdot d\mathbf{r}$$

#### 4.1.6 Proposition: Line Integral of the Sum of Vector Fields

Let  $\mathbf{F}, \mathbf{G} : \mathbb{R}^n \rightarrow \mathbb{R}^n$  be two vector fields and let  $\Gamma \subset \mathbb{R}^n$  be a curve parameterized by the smooth function  $\mathbf{r} : \mathbb{R} \rightarrow \mathbb{R}^n$ . In this case

$$\int_{\Gamma} (\mathbf{F} + \mathbf{G})(\mathbf{r}) \cdot d\mathbf{r} = \int_{\Gamma} \mathbf{F}(\mathbf{r}) \cdot d\mathbf{r} + \int_{\Gamma} \mathbf{G}(\mathbf{r}) \cdot d\mathbf{r}$$

## 4.2 Vector Fields

### 4.2.1 Definition: Gradient

Let  $u : D \subset \mathbb{R}^n \rightarrow \mathbb{R}$  be a scalar function of  $n$  variables  $x_1, x_2, \dots, x_n$  and let  $p \in \mathbb{R}^n$  be a point in  $\mathbb{R}^n$ . The gradient of  $u$ , denoted by  $\nabla u$ , is the vector field given by

$$\nabla u(p) = \left( \frac{\partial u}{\partial x_1}, \frac{\partial u}{\partial x_2}, \dots, \frac{\partial u}{\partial x_n} \right)$$

mapping the point  $p \in \mathbb{R}^n$  to the vector  $\nabla u(p) \in \mathbb{R}^n$ .

### 4.2.2 Definition: Conservative Vector Field

A conservative vector field is a vector field that is the gradient of a multivariable scalar function (or scalar field). More formally, the vector field  $\mathbf{F} : D \subset \mathbb{R}^n \rightarrow \mathbb{R}^n$  is a conservative field if there exists scalar function  $u : D \rightarrow \mathbb{R}$  such that

$$\mathbf{F} = \nabla u$$

### 4.2.3 Theorem: The Gradient Theorem for Line Integrals

The gradient theorem generalizes the fundamental theorem of calculus. Let  $\mathbf{F} : D \subset \mathbb{R}^n \rightarrow \mathbb{R}^n$  be a conservative vector field and let  $u : D \rightarrow \mathbb{R}$  be a continuously differentiable scalar function such that  $\mathbf{F} = \nabla u$ . More so, let  $I = [a, b]$  be an interval in  $\mathbb{R}$ , let the smooth function  $\mathbf{r} : I \rightarrow \mathbb{R}^n$  parameterize the curve  $\Gamma$ , and let  $\boldsymbol{\alpha} = \mathbf{r}(a)$  and  $\boldsymbol{\beta} = \mathbf{r}(b)$  be the endpoints of  $\Gamma$ . In this case,

$$\int_{\Gamma} \mathbf{F}(\mathbf{r}) \cdot d\mathbf{r} = u(\boldsymbol{\beta}) - u(\boldsymbol{\alpha})$$

### 4.2.4 Proposition: Equivalent Properties of Vector Fields

If  $\mathbf{F} : D \subset \mathbb{R}^n \rightarrow \mathbb{R}^n$  is a vector field, the following properties are equivalent:

1.  $\mathbf{F}$  is a conservative field.
2. The line integral of  $\mathbf{F}$  over any closed path is equal to zero.
3. The line integral of  $\mathbf{F}$  between any two points is independent of the path taken and depends only on the starting and ending point of the curve.

### 4.3 Surface Integrals

A surface integral is an integral of a function (or field) evaluated on a surface.

#### 4.3.1 Surface Integral of a Scalar Field

Let  $D \subset \mathbb{R}^2$  be a connected subset of  $\mathbb{R}^2$  and let  $\mathbf{r} : D \rightarrow \mathbb{R}^3$  mapping  $(u, v) \mapsto \mathbf{r}(u, v)$  be a continuously differentiable vector function parametrizing the surface  $\mathcal{S}$ . Finally, let  $f : \mathbb{R}^3 \rightarrow \mathbb{R}$  be a scalar field. In this case, the surface integral of  $f$  over the surface  $\mathcal{S}$  is given by:

$$\iint_{\mathcal{S}} f \, d\mathcal{S} = \iint_D f(\mathbf{r}(u, v)) \|\mathbf{r}_u \times \mathbf{r}_v\| \, du \, dv$$

where  $\mathbf{r}_u$  and  $\mathbf{r}_v$  are  $\mathbf{r}$ 's partial derivatives with respect to  $u$  and  $v$ , respectively.

#### 4.3.2 Proposition: The Surface Integral of a Scalar Field is Independent of Parametrization

The surface integral of a scalar field is independent of the surface's parametrization.

More formally, if  $\mathcal{S}$  is a surface in Euclidean space,  $D, \Delta \subset \mathbb{R}^2$  are connected subsets of  $\mathbb{R}^2$ , and the continuously differentiable vector functions  $\mathbf{r} : D \rightarrow \mathbb{R}^3$  mapping  $(u, v) \mapsto \mathbf{r}(u, v)$  and  $\boldsymbol{\rho} : \Delta \rightarrow \mathbb{R}^3$  mapping  $(\mu, \nu) \mapsto \boldsymbol{\rho}(\mu, \nu)$  are two parameterizations of  $\mathcal{S}$ , then

$$\iint_D f(\mathbf{r}(u, v)) \|\mathbf{r}_u \times \mathbf{r}_v\| \, du \, dv = \iint_{\Delta} f(\boldsymbol{\rho}(\mu, \nu)) \|\boldsymbol{\rho}_\mu \times \boldsymbol{\rho}_\nu\| \, d\mu \, d\nu$$

#### 4.3.3 Definition: Surface Integral of a Vector Field

Let  $\mathcal{S} \subset \mathbb{R}^3$  be a surface and let  $\mathbf{N} : \mathcal{S} \rightarrow \mathbb{R}^3$  be the vector function mapping points on  $\mathcal{S}$  to the unit normal vector  $\mathbf{N}$  at that point. Finally, let  $\mathbf{F} : \mathcal{S} \rightarrow \mathbb{R}^3$  be a vector field. In this case:

$$\iint_{\mathcal{S}} \mathbf{F} \cdot d\mathbf{S} = \iint_{\mathcal{S}} \mathbf{F} \cdot \mathbf{N} \, d\mathcal{S}$$

#### 4.3.4 Note: Alternate Formulation of the Surface Integral of a Vector Field

Let  $D \subset \mathbb{R}^2$  be a connected subset of  $\mathbb{R}^2$ , let  $\mathbf{r} : D \rightarrow \mathcal{S} \subset \mathbb{R}^3$  mapping  $(u, v) \mapsto \mathbf{r}(u, v)$  be a continuously differentiable vector function parametrizing the surface  $\mathcal{S}$ . Finally, let  $\mathbf{F} : \mathcal{S} \rightarrow \mathbb{R}^3$  be a vector field. In this case:

$$\iint_{\mathcal{S}} \mathbf{F} \cdot d\mathbf{S} = \iint_D \mathbf{F}(\mathbf{r}(u, v)) \cdot (\mathbf{r}_u \times \mathbf{r}_v) \, du \, dv$$

## 4.4 Vector Operators

### 4.4.1 Definition: Curl in Euclidean Space

Let  $\mathbf{F} : D \subset \mathbb{R}^3 \rightarrow \mathbb{R}^3$  be a vector field in Euclidean space with scalar components  $(F_x, F_y, F_z)$ . The curl of  $\mathbf{F}$ , denoted by  $\nabla \times \mathbf{F}$ , is defined as

$$\nabla \times \mathbf{F} = \left( \frac{\partial F_z}{\partial y} - \frac{\partial F_y}{\partial z} \right) \hat{\mathbf{i}} + \left( \frac{\partial F_x}{\partial z} - \frac{\partial F_z}{\partial x} \right) \hat{\mathbf{j}} + \left( \frac{\partial F_y}{\partial x} - \frac{\partial F_x}{\partial y} \right) \hat{\mathbf{k}}$$

or, in matrix form

$$\nabla \times \mathbf{F} = \begin{bmatrix} \frac{\partial F_z}{\partial y} - \frac{\partial F_y}{\partial z} \\ \frac{\partial F_x}{\partial z} - \frac{\partial F_z}{\partial x} \\ \frac{\partial F_y}{\partial x} - \frac{\partial F_x}{\partial y} \end{bmatrix}$$

#### 4.4.2 Proposition: Curl of a Conservative Vector Field

The curl of a conservative vector field is zero. More formally, if  $\mathbf{F} : D \subset \mathbb{R}^3 \rightarrow \mathbb{R}^3$  is a conservative vector field and  $\mathbf{p} = (x, y, z)$  denotes a point in Euclidean space, then

$$(\nabla \times \mathbf{F})(\mathbf{p}) = \mathbf{0} \quad \forall \quad \mathbf{p} \in D$$

where  $\mathbf{0}$  denotes the zero vector.

#### 4.4.3 Definition: Divergence in Euclidean Space

Divergence is an vector operator that operates on a vector field to produce a scalar field. If  $\mathbf{F} : \Omega \subset \mathbb{R}^3 \rightarrow \mathbb{R}^3$  with scalar components  $\mathbf{F} = (F_x, F_y, F_z)$ , the divergence of  $\mathbf{F}$ , denoted by  $\nabla \cdot \mathbf{F}$ , is the scalar field  $\nabla \cdot \mathbf{F} : \Omega \rightarrow \mathbb{R}$  given by:

$$\nabla \cdot \mathbf{F} = \frac{\partial F_x}{\partial x} + \frac{\partial F_y}{\partial y} + \frac{\partial F_z}{\partial z}$$

#### 4.4.4 Definition: Laplacian in Euclidean Space

The Laplacian, or Laplace operator, is a differential operator giving the divergence of a scalar field's gradient. More formally, let  $f : \Omega \subset \mathbb{R}^3 \rightarrow \mathbb{R}$  be a twice differentiable scalar field. The Laplacian of  $f$ , denoted by  $\Delta f$  or  $\nabla^2 f$ , is the scalar field  $\Delta f : \Omega \rightarrow \mathbb{R}$  given:

$$\Delta f = \nabla \cdot \nabla f = \frac{\partial^2 f}{\partial x^2} + \frac{\partial^2 f}{\partial y^2} + \frac{\partial^2 f}{\partial z^2}$$

#### 4.4.5 Note: Harmonic Functions

Scalar functions whose Laplacian is zero are called harmonic functions. More formally, if  $f : \Omega \subset \mathbb{R}^3 \rightarrow \mathbb{R}$  is a twice continuously differentiable scalar function such that

$$\Delta f = 0$$

then  $f$  is a harmonic function.

#### 4.4.6 Proposition: Properties of Vector Operators

Let  $f, g : \mathbb{R}^3 \rightarrow \mathbb{R}$  be two continuously differentiable scalar fields and let  $\mathbf{F}, \mathbf{G} : \mathbb{R}^3 \rightarrow \mathbb{R}^3$  be two vector fields. In this case:

1.  $\nabla(fg) = g\nabla f + f\nabla g$
2.  $\nabla \cdot (f\mathbf{F}) = \langle f, \nabla \mathbf{F} \rangle + \langle \nabla f, \mathbf{F} \rangle$
3.  $\nabla \cdot (\mathbf{F} \times \mathbf{G}) = \langle \mathbf{G}, \nabla \times \mathbf{F} \rangle - \langle \mathbf{F}, \nabla \times \mathbf{G} \rangle$

where  $\langle \cdot, \cdot \rangle$  denotes the standard scalar Euclidean product.

## 4.5 Important Theorems in Vector Analysis

### 4.5.1 Gauss's Theorem (Divergence Theorem)

Let  $V \subset \mathbb{R}^3$  be a closed and bounded (or, more generally, compact) subset of  $\mathbb{R}^3$  with a piecewise smooth boundary  $S = \partial V$  where  $S$  is a piecewise smooth surface with outward orientation. More so, let  $\mathbf{F}$  be a continuously differentiable vector field defined on a neighborhood of  $V$ . In this case:

$$\iint_S \mathbf{F} \cdot d\mathbf{S} = \iiint_V \nabla \cdot \mathbf{F} \, dV$$

### 4.5.2 Green's Theorem

Let  $D \subset \mathbb{R}^2$  be a bounded subset of  $\mathbb{R}^2$  with a closed, piecewise continuous border  $\partial D = C$  such that  $C$  is positively oriented. More so, let  $\mathbf{F}$  be a continuously differentiable vector field defined on a neighborhood of  $D$  with scalar components given by  $\mathbf{F}(x, y) = (X(x, y), Y(x, y))$ . In this case:

$$\oint_C X \, dx + Y \, dy = \iint_D \left( \frac{\partial Y}{\partial x} - \frac{\partial X}{\partial y} \right)$$

where the direction of integration in the integral  $\oint_C$  is in the positive direction of the curve  $C$ .

### 4.5.3 Stoke's Theorem in $\mathbb{R}^3$

Let  $\Sigma \subset \mathbb{R}^3$  be a bounded, outward oriented, piecewise smooth surface in  $\mathbb{R}^3$  with piecewise continuous border  $\partial\Sigma$ . More so, let  $\mathbf{F}$  be a continuously differentiable vector field defined on a neighborhood of  $\Sigma$ . In this case:

$$\int_{\partial\Sigma} \mathbf{F} \cdot d\mathbf{s} = \iint_{\Sigma} \nabla \times \mathbf{F} \cdot d\mathbf{S}$$

Where  $d\mathbf{s}$  denotes a line element of  $\partial\Sigma$  and  $d\mathbf{S}$  denotes an area element of  $\Sigma$ .

### 4.5.4 Green's First Two Identities

Let  $\Omega \subset \mathbb{R}^3$  be an open, bounded subset of  $\mathbb{R}^3$  with a piecewise continuous border  $\partial\Omega$ , let  $u, v$  be smooth scalar fields defined on a neighborhood of  $\bar{\Omega}$ , and let  $\mathbf{n}$  denote the outward-pointing normal vector to border  $\partial\Omega$ . In this case, Green's first two identities are:

$$\begin{aligned} \iint_{\partial\Omega} u \frac{\partial v}{\partial \mathbf{n}} \, dS &= \iiint_{\Omega} (u\Delta v + \nabla u \cdot \nabla v) \, dV \\ \iint_{\partial\Omega} \left( u \frac{\partial v}{\partial \mathbf{n}} - v \frac{\partial u}{\partial \mathbf{n}} \right) \, dS &= \iiint_{\Omega} (u\Delta v - v\Delta u) \, dV \end{aligned}$$

where  $\frac{\partial v}{\partial \mathbf{n}} = \nabla v \cdot \mathbf{n}$  denotes the directional derivative of  $v$  in the direction of  $\mathbf{n}$ .

### 4.5.5 Conservative Vector Field on a Star Domain

Let  $S \subset \mathbb{R}^3$  be a closed, bounded star domain in  $\mathbb{R}^3$ , and let  $\mathbf{F} : S \rightarrow \mathbb{R}^3$  be a vector field defined on the set  $S$  such that  $\nabla \times \mathbf{F} = 0$  for all  $\mathbf{x} \in S$ . In this case,  $\mathbf{F}$  is a conservative vector field and there exists scalar field  $f : S \rightarrow \mathbb{R}$  such that  $\mathbf{F} = \nabla f$ .

## 5 Differential Equations

### 5.1 Ordinary First Order Differential Equations

#### 5.1.1 Homogeneous Differential Equation

A homogeneous differential equation is a differential equation of the form

$$y' = f(x, y)$$

where  $f$  is a homogeneous function of order 0, meaning that  $f(tu, tv) = f(u, v)$  for  $t > 0$ .

To solve a homogeneous DE, we start by applying the 0th order homogeneity.

$$f(x, y) = f\left(x, \frac{y}{x}\right)$$

We introduce a new variable  $z = \frac{y}{x}$  with  $y' = z'x + z$  and our DE takes the form

$$z'x + z = f(1, z)$$

$$z'x = f(1, z) - z$$

$$\frac{dx}{x} = \frac{dz}{f(1, z) - z}$$

$$\frac{dx}{x} = \frac{dz}{g(z)}$$

where  $g(z) := f(1, z) - z$ . This is an equation with separable variables, which can be solved for  $z$  by integrating both sides. Once  $z$  is found, we plug in  $y = zx$ .

#### 5.1.2 Definition: First Integral

A first integral of the first-order differential equation  $y' = f(x, y)$  is a function  $u = u(a, b)$  such that

$$u(x, y(x)) = C \quad C \in \mathbb{R}$$

for each solution  $y = y(x)$  of the differential equation. Note that the set of all  $(a, b)$  such that  $u(a, b) = C$  is a level set.

#### 5.1.3 Definition: Exact Differential Equation

The differential equation

$$P(x, y) dx + Q(x, y) dy = 0$$

is exact if any of the equivalent conditions hold:

1. The vector field  $\mathbf{F} = (P, Q)$  is conservative
2. There exists a scalar function  $u(x, y)$  such that  $\mathbf{F} = (P, Q) = \nabla u$
3.  $P_y = Q_x$



### 5.1.4 Integrating Factor

Lets have a differential equation, not necessarily exact, of the form

$$P(x, y) dx + Q(x, y) dy = 0$$

For the special cases where either  $\frac{P_y - Q_x}{Q}$  is independent of  $y$  or  $\frac{Q_x - P_y}{P}$  is independent of  $x$ , we have the integrating factors

$$\begin{aligned}\mu(x) &= \exp\left(\int \frac{P_y - Q_x}{Q} dx\right) \\ \mu(y) &= \exp\left(\int \frac{Q_x - P_y}{P} dx\right)\end{aligned}$$

### 5.1.5 Parametric Solution Case 1

Our goal is to describe the family of curves solving the differential equation

$$F(x, y') = 0$$

parametrically. We denote  $y' = \frac{dy}{dx}$ ,  $\dot{y} = \frac{dy}{dt}$ , and  $\dot{x} = \frac{dx}{dt}$ . Next, we introduce the parametric functions

$$\begin{aligned}x(t) &= \psi(t) \\ y'(t) &= \frac{dy}{dx} = \theta(t)\end{aligned}$$

Our goal is to find an expression for  $y(t)$ . We apply the chain rule to the composition  $y \circ x$  to get

$$\frac{d[y \circ x]}{dt} = \frac{dy}{dx} \frac{dx}{dt} \implies \frac{d[y \circ x]}{dt} \equiv \dot{y}(t) = \frac{dy}{dx} \frac{dx}{dt}$$

It follows that

$$\dot{y}(t) = \theta(t)\dot{\psi}(t) \implies y(t) = \int \theta(t)\dot{\psi}(t) dt = \int y'(t)\dot{x}(t) dt$$

In this case, the functions  $y(t)$  and  $x(t)$  parameterize the solution to the differential equation.

### 5.1.6 Parametric Solution Case II

Our goal is to describe the family of curves solving the differential equation

$$F(y, y') = 0$$

parametrically. We denote  $y' = \frac{dy}{dx}$ ,  $\dot{y} = \frac{dy}{dt}$ , and  $\dot{x} = \frac{dx}{dt}$ . Next, we introduce the parametric functions

$$\begin{aligned}y(t) &= \psi(t) \\ y'(t) &= \frac{dy}{dx} = \theta(t)\end{aligned}$$

Our goal is to find an expression for  $x(t)$ . We apply the chain rule to the composition  $y \circ x$  to get

$$\frac{d[y \circ x]}{dt} = \frac{dy}{dx} \frac{dx}{dt} \implies \frac{d[y \circ x]}{dt} \equiv \dot{y}(t) = \frac{dy}{dx} \frac{dx}{dt}$$

It follows that

$$\dot{\psi}(t) = \theta(t)\dot{x}(t) \quad \implies \quad x(t) = \int \frac{\dot{\psi}(t)}{\theta(t)} dt = \int \frac{\dot{y}(t)}{y'(t)} dt$$

In this case, functions  $y(t)$  and  $x(t)$  parameterize the solution to the differential equation.

### 5.1.7 Clairaut Differential Equation

The Clairaut differential equation has the form

$$y = xy' + f(y')$$

where  $f \in C^1$  is a continuously differentiable function.

We solve the equation by differentiating with respect to  $x$  to get:

$$\begin{aligned} y' &= y' + xy'' + f'(y')y'' \\ 0 &= y''(x + f'(y')) \end{aligned}$$

It follows that either  $y'' = 0$ , which gives the solution

$$y = Cx + f(C)$$

which is a family of linear functions parameterized by the constant  $C$ . This solution is called the general solution.

The alternative option

$$x + f'(y') = 0$$

can be written as  $F(x, y') = 0$  and solved parametrically using previous techniques. The resulting solution for  $y(x)$  is called the singular solution. The graph of the singular solution is the envelope of the graphs of the general solutions.

## 5.2 Metric Spaces and Picard's Existence Theorem

### 5.2.1 Review: Metric Spaces

A metric space  $(M, d)$  is a set  $M$  equipped with a metric  $d : M \times M \rightarrow \mathbb{R}^+$  that measures the distance elements of  $M$ . For each  $u, v, w \in M$ , the metric  $d$  must satisfy:

$$\begin{aligned} d(u, v) &\leq 0 \quad \text{and} \quad d(u, v) = 0 \iff v = u \\ d(u, v) &= d(v, u) \\ d(u, w) &\leq d(u, v) + d(v, w) \end{aligned}$$

### 5.2.2 Definition: Lipschitz Continuity

Let  $(M, d_m)$  and  $(N, d_n)$  be two metric spaces. The function  $\phi : M \rightarrow N$  mapping from  $M$  to  $N$  is said to be Lipschitz continuous if there exists a non-negative real constant  $\gamma \in \mathbb{R}^+$  such that for each  $m_1, m_2 \in M$

$$d_n(\phi(m_1), \phi(m_2)) \leq \gamma d_m(m_1, m_2)$$

If the special case of a real function  $f : \mathbb{R} \rightarrow \mathbb{R}$  equipped with the standard metric  $d(x_1, x_2) = |x_2 - x_1|$ , the function  $f$  is Lipschitz continuous if there exists a non-negative real constant  $\gamma \in \mathbb{R}^+$  such that for all  $x_1, x_2 \in \mathbb{R}$

$$|f(x_1) - f(x_2)| \leq \gamma |x_1 - x_2|$$

### 5.2.3 Review: Banach's Fixed-Point Theorem

Let  $(M, d)$  be a complete metric space and let  $\phi : M \rightarrow M$  be a contraction mapping (i.e. a Lipschitz continuous function from  $M$  to  $M$  with Lipschitz constant  $\gamma < 1$ ). In this case, there exists exactly one fixed point  $a \in M$  such that  $\phi(a) = a$ . More so, for the sequence  $x_n = (\phi \circ \dots \circ \phi)(x)$  defined as  $n$  compositions of the function  $\phi$ , we have:

$$\lim_{n \rightarrow \infty} x_n(x) = a$$

for each  $x \in M$ .

### 5.2.4 Theorem: Picard's Existence Theorem

Let  $x_0, y_0 \in \mathbb{R}$  be real numbers and let  $P := [x_0 - a, x_0 + a] \times [y_0 - b, y_0 + b] \subset \mathbb{R}^2$  be a rectangle in  $\mathbb{R}^2$ . Let  $f : P \rightarrow \mathbb{R}$  be a continuous function such that  $f$  is uniformly Lipschitz continuous in the second variable  $y$ , meaning there exists Lipschitz constant  $\gamma > 0$  such that for each  $(x, y_1), (x, y_2) \in P$ ,

$$|f(x, y_1) - f(x, y_2)| \leq \gamma|y_2 - y_1|$$

In this case, there exists exactly one solution to the initial-value problem

$$y'(x) = f(x, y(x)), \quad y(x_0) = y_0.$$

## 5.3 System of Linear Differential Equations

### 5.3.1 Definition: Homogeneous System of LDEs with Constant Coefficients

Define the function  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  and the constant matrix of coefficients  $\mathbf{A} \in \mathbb{R}^{n \times n}$ . In this case, the matrix equation

$$\mathbf{y}'(x) = \mathbf{A}\mathbf{y}(x)$$

is a homogeneous system of linear differential equations with constant coefficients.

### 5.3.2 Definition: Non-Homogeneous System of LDEs with Constant Coefficients

Define the functions  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  and  $\mathbf{b} : I \rightarrow \mathbb{R}^n$  and the constant matrix of coefficients  $\mathbf{A} \in \mathbb{R}^{n \times n}$ . In this case, the matrix equation

$$\mathbf{y}'(x) = \mathbf{A}\mathbf{y}(x) + \mathbf{b}(x)$$

is a non-homogeneous system of linear differential equations with constant coefficients.

### 5.3.3 Solution of a Homogeneous System of LDEs with Constant Coefficients

Define the function  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  and the constant matrix of coefficients  $\mathbf{A} \in \mathbb{R}^{n \times n}$  and let

$$\mathbf{y}'(x) = \mathbf{A}\mathbf{y}(x)$$

be a homogeneous system of linear differential equations with constant coefficients. The solution to this homogeneous system can be written:

$$\mathbf{y}(x) = \mathbf{c}e^{x\mathbf{A}}$$

where  $\mathbf{c} \in \mathbb{R}^n$  is a constant vector.

**5.3.4 Definition: Homogeneous and Non-Homogeneous System of First-Order LDEs with Variable Coefficients**

Let  $I \subset \mathbb{R}$  be an interval on the real line, and let  $a_{ij}, b_j : I \rightarrow \mathbb{R}$  be continuous functions with indexes in the range  $i, j \in \{1, 2, \dots, n\}$ . Let  $\mathbf{A} : I \rightarrow \mathbb{R}^{n \times n}$  be a matrix function defined as:

$$\mathbf{A}(x) := \begin{bmatrix} a_{11}(x) & \dots & a_{1n}(x) \\ \vdots & \ddots & \vdots \\ a_{n1}(x) & \dots & a_{nn}(x) \end{bmatrix} \in \mathbb{R}^{n \times n}$$

and let  $\mathbf{b} : I \rightarrow \mathbb{R}^n$  and  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  be a vector functions of one variable defined as:

$$\mathbf{b}(x) := \begin{bmatrix} b_1(x) \\ \vdots \\ b_n(x) \end{bmatrix} \in \mathbb{R}^n \quad \text{and} \quad \mathbf{y}(x) := \begin{bmatrix} y_1(x) \\ \vdots \\ y_n(x) \end{bmatrix} \in \mathbb{R}^n$$

In this case, the matrix equations

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x) \quad \text{and} \quad \mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x) + \mathbf{b}(x)$$

are homogeneous and nonhomogeneous systems of first-order linear differential equations with constant coefficients, respectively.

**5.3.5 Proposition: Equivalent Properties of Systems of Linear Differential Equations**

Let  $I \subset \mathbb{R}$  be an interval on the real line and let the vector-valued functions  $\mathbf{y}_1, \mathbf{y}_2, \dots, \mathbf{y}_k : I \rightarrow \mathbb{R}^n$  be solutions of the homogeneous system  $\mathbf{y}' = \mathbf{A}\mathbf{y}$  on the interval  $I$ . In this case, the following are equivalent:

1. The vector functions  $\mathbf{y}_1, \mathbf{y}_2, \dots, \mathbf{y}_k$  are linearly independent.
2. There exists  $x_0 \in I$  such that the vectors  $\mathbf{y}_1(x_0), \mathbf{y}_2(x_0), \dots, \mathbf{y}_k(x_0)$  are linearly independent in  $\mathbb{R}^n$ .
3. The vectors  $\mathbf{y}_1(x), \mathbf{y}_2(x), \dots, \mathbf{y}_k(x)$  are linearly independent in  $\mathbb{R}^n$  for all  $x \in I$ .

**5.3.6 Theorem: Dimension of Solution Set**

Let  $I \subset \mathbb{R}$  be an interval on the real line, let  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  be a vector valued function with  $n$  scalar components  $(y_1, y_2, \dots, y_n)$ , and let  $\mathbf{A} : I \rightarrow \mathbb{R}_{n \times n}$  be a matrix function. In this case, the solution set to the homogeneous system of first-order linear differential equations

$$\mathbf{y}' = \mathbf{A}\mathbf{y}$$

is  $n$ -dimensional.

**5.3.7 Definition: Fundamental Matrix**

Let  $I \subset \mathbb{R}$  be an interval on the real line, let  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  be a vector-valued function and let  $\mathbf{A} : I \rightarrow \mathbb{R}^{n \times n}$  be a matrix-valued function, and let

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x)$$

be a system of  $n$  homogeneous linear differential equations. Finally, let  $\mathbf{y}_1, \mathbf{y}_2, \dots, \mathbf{y}_n$  be  $n$  linearly independent solutions to the homogeneous system

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x)$$

In this case, the fundamental matrix  $\mathbf{Y} : I \rightarrow \mathbb{R}^{n \times n}$  is a matrix-valued function whose columns are the linearly independent solutions to the homogeneous system. In other words

$$\mathbf{Y} = [y_1, y_2, \dots, y_n]$$

### 5.3.8 Proposition: Solution in Terms of Fundamental Matrix

Let  $I \subset \mathbb{R}$  be an interval on the real line, let  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  be a vector-valued function, let  $\mathbf{A} : I \rightarrow \mathbb{R}^{n \times n}$  be a matrix-valued function, and let

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x)$$

be a system of  $n$  homogeneous linear differential equations with the fundamental matrix  $\mathbf{Y} : I \rightarrow \mathbb{R}^{n \times n}$ . In this case, every solution to the system can be written in the form

$$\mathbf{y}(x) = \mathbf{Y}(x)\mathbf{c}$$

where  $\mathbf{c} \in \mathbb{R}^n$  is a constant vector.

### 5.3.9 Proposition: Condition for Fundamental Matrix

Let  $I \subset \mathbb{R}$  be an interval on the real line, let  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  be a vector-valued function, let  $\mathbf{A} : I \rightarrow \mathbb{R}^{n \times n}$  be a matrix-valued function, and let

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x)$$

be a system of  $n$  homogeneous linear differential equations. In this case, the matrix-valued function  $\mathbf{Y} : I \rightarrow \mathbb{R}^{n \times n}$  is a fundamental matrix of the system if and only if

$$\mathbf{Y}'(x) = \mathbf{A}(x)\mathbf{Y}(x)$$

and  $\mathbf{Y}(x)$  is invertible for all  $x$  in  $I$ .

### 5.3.10 Proposition: Particular Solution of a Non-Homogeneous System of LDEs with Variable Coefficients

Let  $I \subset \mathbb{R}$  be an interval on the real line, let  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  and  $\mathbf{b} : I \rightarrow \mathbb{R}^n$  be a vector-valued functions, let  $\mathbf{A} : I \rightarrow \mathbb{R}^{n \times n}$  be a matrix-valued function, and let

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x) + \mathbf{b}(x)$$

be a non-homogeneous system of  $n$  linear differential equations with variable coefficients such that the corresponding homogeneous system

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x)$$

has the fundamental matrix  $\mathbf{Y} : I \rightarrow \mathbb{R}^{n \times n}$  and the homogeneous solution  $\mathbf{y}_h : I \rightarrow \mathbb{R}^n$  given by

$$\mathbf{y}_h(x) = \mathbf{Y}(x)\mathbf{c}$$

where  $\mathbf{c} \in \mathbb{R}^n$  is a vector of constants. In this case, the particular solution  $\mathbf{y}_p(x)$  can be written in the form

$$\mathbf{y}_p(x) = \mathbf{Y}(x)\mathbf{z}(x)$$

where  $\mathbf{Y} = \mathbf{Y}(x)$  is the fundamental matrix and  $\mathbf{z} : I \rightarrow \mathbb{R}^n$  is a vector-valued function given by:

$$\mathbf{z}(x) = \int \mathbf{Y}^{-1}(x)\mathbf{b}(x) dx$$

**Short Derivation:** Differentiate  $\mathbf{y}_p(x) = \mathbf{Y}(x)\mathbf{z}(x)$  with respect to  $x$  to get:

$$\mathbf{y}'_p = \mathbf{Y}'\mathbf{z} + \mathbf{Y}\mathbf{z}' = \mathbf{A}\mathbf{Y}\mathbf{z} + \mathbf{Y}\mathbf{z}' = \mathbf{A}\mathbf{y}_p + \mathbf{Y}\mathbf{z}'$$

Comparing this to the general equation  $\mathbf{y}' = \mathbf{A}\mathbf{y} + \mathbf{b}$  and in particular comparing the last terms it follows that from the particularity of the solution that:

$$\mathbf{b} = \mathbf{Y}\mathbf{z}' \quad \implies \quad \mathbf{z}' = \mathbf{Y}^{-1}\mathbf{b} \quad \implies \quad \mathbf{z} = \mathbf{z}(x) = \int \mathbf{Y}^{-1}(x)\mathbf{b}(x) dx$$

### 5.3.11 Summary: Particular Solution of a Nonhomogeneous System of LDEs with Variable Coefficients

The particular solution  $\mathbf{y}_p$  to the nonhomogeneous system

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x) + \mathbf{b}(x)$$

is

$$\mathbf{y}_p(x) = \mathbf{Y}(x) \int \mathbf{Y}^{-1}(x)\mathbf{b}(x) dx$$

where  $\mathbf{Y}$  is the fundamental matrix of the homogeneous system  $\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x)$ .

### 5.3.12 Proposition: General Solution of a Nonhomogeneous System of LDEs with Variable Coefficients

Let  $I \subset \mathbb{R}$  be an interval on the real line, let  $\mathbf{y}, \mathbf{b} : I \rightarrow \mathbb{R}^n$  be vector-valued functions, let  $\mathbf{A} : I \rightarrow \mathbb{R}^{n \times n}$  be a matrix-valued function, and let

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x) + \mathbf{b}(x)$$

be a non-homogeneous system of  $n$  linear differential equations with variable coefficients with homogeneous solution  $\mathbf{y}_h$  and particular solution  $\mathbf{y}_p$ . In this case, the system has the general solution  $\mathbf{y}_g : I \rightarrow \mathbb{R}^n$

$$\mathbf{y}_g = \mathbf{y}_h + \mathbf{y}_p$$

### 5.3.13 Definition: Wronskian Determinant

Let  $I \subset \mathbb{R}$  be an interval on the real line, let  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  be a vector-valued function, let  $\mathbf{A} : I \rightarrow \mathbb{R}^{n \times n}$  be a matrix-valued function, and let

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x) + \mathbf{b}(x)$$

be a homogeneous system of  $n$  linear differential equations with variable coefficients with fundamental matrix  $\mathbf{Y} : I \rightarrow \mathbb{R}^{n \times n}$ . In this case, the system's Wronskian determinant, often called the Wronskian and denoted by  $W(x)$ , is the determinant:

$$W(x) := \det \mathbf{Y}(x)$$

**5.3.14 Proposition: Wronskian Determinant and Trace**

Let  $I \subset \mathbb{R}$  be an interval on the real line, let  $\mathbf{y} : I \rightarrow \mathbb{R}^n$  be a vector-valued function, let  $\mathbf{A} : I \rightarrow \mathbb{R}^{n \times n}$  be a matrix-valued function, and let

$$\mathbf{y}'(x) = \mathbf{A}(x)\mathbf{y}(x) + \mathbf{b}(x)$$

be a homogeneous system of  $n$  linear differential equations with variable coefficients with fundamental matrix  $\mathbf{Y} : I \rightarrow \mathbb{R}^{n \times n}$  and Wronskian  $W(x) = \det \mathbf{Y}(x)$ . In this case:

$$W'(x) = \text{tr}(\mathbf{A}(x))W(x)$$

and

$$W(x) = C e^{\int_{x_0}^x \text{tr}(\mathbf{A}(\chi))W(\chi) d\chi} \quad \text{for each } x, x_0 \in I$$

where  $C \in \mathbb{R}$  is a constant.

**5.4 Higher-Order Linear Differential Equations with Variable Coefficients**

**Note:** This section is a medley of content from LDEs with constant and not constant coefficients. It stills needs to be cleaned up and may not be correct.

**5.4.1 Definition: Homogeneous and Non-Homogeneous  $n$ th-Order LDE with Constant Coefficients**

Let  $I \in \mathbb{R}$  be an interval on the real line, let  $y : I \rightarrow \mathbb{R}$  be a real function of differentiability class  $C^n$ , let  $b : I \rightarrow \mathbb{R}$  be a real function, and let  $a_0, a_1, \dots, a_n \in \mathbb{R}$  be real constants. In this case, the equations

$$a_0y + a_1y' + \dots + a_ny^{(n)} = 0 \quad \text{or} \quad \sum_{i=0}^n a_iy^{(i)} = 0 \quad \text{and}$$

$$a_0y + a_1y' + \dots + a_ny^{(n)} = b(x) \quad \text{or} \quad \sum_{i=0}^n a_iy^{(i)} = b(x)$$

are homogeneous and non-homogeneous  $n$ th order linear differential equations with constant coefficients, respectively.

**5.4.2 Proposition: Matrix Representation of an  $n$ th Order LDE**

Let  $I \in \mathbb{R}$  be an interval on the real line, let  $y : I \rightarrow \mathbb{R}$  be a real function of differentiability class  $C^n$ , let  $b : I \rightarrow \mathbb{R}$  be a real function, and let  $a_0, a_1, \dots, a_n \in \mathbb{R}$  be real constants and let

$$\sum_{i=0}^n a_iy^{(i)} = b(x)$$

be a non-homogeneous  $n$ th order linear differential equation with constant coefficients. Define the functions  $z_1, z_2, \dots, z_n : I \rightarrow \mathbb{R}$  given by:

$$\begin{array}{ll} z_1 := y & z_1' = z_2 \\ z_2 := y' & z_2' = z_3 \\ z_n := y^{(n-1)} & z_{n-1}' = z_n \end{array}$$

In this case, the functions  $z_1, z_2, \dots, z_n$  satisfy the relationships:

$$\sum_{i=0}^n a_i z_{i+1} + a_n z'_n = b \qquad z'_n = \frac{1}{a_n} \left( b - \sum_{i=1}^n a_{i-1} z_i \right)$$

And the  $n$ th order equation  $\sum_{i=0}^n a_i y^{(i)} = b(x)$  is equivalently represented by the matrix system:

$$\begin{bmatrix} z'_1 \\ \vdots \\ z'_n \end{bmatrix} = \begin{bmatrix} 0 & 1 & 0 & \dots & 0 \\ 0 & 0 & 1 & \dots & 0 \\ \vdots & \ddots & \dots & \ddots & 0 \\ 0 & 0 & 0 & \dots & 1 \\ -\frac{a_0}{a_n} & -\frac{a_1}{a_n} & -\frac{a_2}{a_n} & \dots & -\frac{a_{n-1}}{a_n} \end{bmatrix} \begin{bmatrix} z_1 \\ \vdots \\ z_n \end{bmatrix} + \begin{bmatrix} 0 \\ \vdots \\ 0 \\ \frac{b}{a_n} \end{bmatrix}$$

### 5.4.3 Proposition: Dimensions of Solution Set

The solution set of the homogeneous  $n$ th order linear differential equation

$$\sum_{i=0}^n a_i y^{(i)} = 0$$

is a  $n$ -dimensional vector space. In particular, this implies that the solution set consists of  $n$  linearly independent functions  $y_1, y_2, \dots, y_n$ .

### 5.4.4 Definition: Fundamental Matrix of an $n$ th Order LDE

Let  $\sum_{i=0}^n a_i y^{(i)} = 0$  be homogeneous  $n$ th order linear differential equation with the linearly independent solutions  $y_1, y_2, \dots, y_n$ . In this case, the equation's fundamental matrix  $\mathbf{Y}$  is the  $n \times n$  matrix:

$$\mathbf{Y} = \begin{bmatrix} y_1 & \dots & y_n \\ \vdots & \ddots & \vdots \\ y_1^{(n-1)} & \dots & y_n^{(n-1)} \end{bmatrix}$$

### 5.4.5 Definition: Wronskian of an $n$ th Order LDE

Let  $\mathbf{Y}$  be the fundamental matrix for the homogeneous  $n$ th order linear differential equation  $\sum_{i=0}^n a_i y^{(i)} = 0$ . In this case, we define the Wronskian as:

$$W = \det \mathbf{Y}$$

### 5.4.6 Proposition: Wronskian and Trace

Let  $\sum_{i=0}^n a_i y^{(i)} = 0$  be homogeneous  $n$ th order linear differential equation defined on the real interval  $I \subset \mathbb{R}$  with fundamental matrix  $\mathbf{Y}$  and Wronskian  $W(x)$ . In this case, for all  $x, x_0 \in I$

$$W(x) = W(x_0) e^{-\int_{x_0}^x \text{tr} \mathbf{A}(\zeta) d\zeta}$$



where the matrix  $\mathbf{A}$  is defined as above

$$\mathbf{A} = \begin{bmatrix} 0 & 1 & 0 & \dots & 0 \\ 0 & 0 & 1 & \dots & 0 \\ \vdots & \ddots & \ddots & \ddots & 0 \\ 0 & 0 & 0 & \dots & 1 \\ -\frac{a_0}{a_n} & -\frac{a_1}{a_n} & -\frac{a_2}{a_n} & \dots & -\frac{a_{n-1}}{a_n} \end{bmatrix}$$

Note that the trace  $\text{tr } \mathbf{A}(x)$  is simply equal to the bottom right matrix element:

$$\text{tr } \mathbf{A}(x) = \frac{-a_{n-1}(x)}{a_n(x)}$$

#### 5.4.7 Variation of Parameters for an $n$ th Order LDE

Let  $\sum_{i=0}^n a_i(x)y^{(i)}(x) = b(x)$  be a non-homogeneous  $n$ th order LDE and let  $y_1, y_2, \dots, y_n$  be the solutions to the homogeneous equation  $\sum_{i=0}^n a_i(x)y^{(i)}(x) = 0$ .

In this case, the particular solution  $y_p$  of the equation is:

$$y_p = c_1 y_1 + \dots + c_n y_n = \sum_{i=1}^n c_i y_i$$

To reach the same answer in matrix form, we define

$$\mathbf{Y}(x) = \begin{bmatrix} y_1 & \dots & y_n \\ \vdots & \ddots & \vdots \\ y_1^{(n-1)} & \dots & y_n^{(n-1)} \end{bmatrix} \quad \mathbf{b}(x) = \begin{bmatrix} 0 \\ \vdots \\ 0 \\ \frac{b(x)}{a_n} \end{bmatrix} \quad \mathbf{y}(x) = \begin{bmatrix} y_1(x) \\ \vdots \\ y_n(x) \end{bmatrix}$$

In this case the particular solution  $y_p$  is given by the dot product

$$y_p = \mathbf{y}(x) \cdot \left[ \int \mathbf{Y}^{-1}(x) \mathbf{b}(x) dx \right]$$

#### 5.4.8 General Solution to a Non-Homogeneous $n$ th Order LDE

Let

$$\sum_{i=0}^n a_i(x)y^{(i)}(x) = b(x)$$

be a non-homogeneous  $n$ th order linear differential equation with the homogeneous solution  $y_h$  and the particular solution  $y_p$ . In this case, the general solution  $y_g$  to the equation is

$$y_g = y_h + y_p$$

## 5.5 Higher-Order LDEs with Constant Coefficients

### 5.5.1 Definition: LDE with Constant Coefficients

Let  $n \in \mathbb{N}$  be an integer, let  $a_n, \dots, a_0 \in \mathbb{R}$  be real constants, and let  $b : \mathbb{R} \rightarrow \mathbb{R}$  be a function. In this case, an  $n$ th order linear differential equation with coefficients is a differential equation of the form

$$a_n y^{(n)} + \dots + a_1 y' + a_0 y = b(x)$$

If additionally  $b(x) = 0$ , the equation is called a *homogeneous* linear differential equation with constant coefficients.

$$a_n y^{(n)} + \dots + a_1 y' + a_0 y = 0 \quad (\text{homogeneous})$$

### 5.5.2 Note: Operator Notation for LDE with Constant Coefficients

Let  $n \in \mathbb{N}$  be an integer, let  $a_n, \dots, a_0 \in \mathbb{R}$  be real constants, and let  $b : \mathbb{R} \rightarrow \mathbb{R}$  be a function and let  $L$  be the differential operator

$$L = \sum_{i=0}^n a_i \frac{d^i}{dx^i} = a_0 + a_1 \frac{d}{dx} + \dots + a_n \frac{d^n}{dx^n}$$

In terms of  $L$ , a linear differential equation with constant coefficients is written

$$Ly = b(x) \iff \sum_{i=0}^n a_i y^{(i)} = a_n y^{(n)} + \dots + a_1 y' + a_0 y = b(x)$$

### 5.5.3 Trial Solution and Characteristic Polynomial

To solve the homogeneous linear differential equation

$$Ly \equiv a_n y^{(n)} + \dots + a_1 y' + a_0 y = 0$$

we use the trial solution  $y(x) = e^{\lambda x}$ . When plugged into the equation, the trial solution gives the equation:

$$L(e^{\lambda x}) = (a_n \lambda^n + \dots + a_1 \lambda + a_0) e^{\lambda x} = 0$$

The complex polynomial  $p : \mathbb{R} \rightarrow \mathbb{C}$  given by:

$$p(\lambda) = a_n \lambda^n + \dots + a_1 \lambda + a_0$$

is called the characteristic polynomial of the differential equation.

### 5.5.4 Solution in Terms of Characteristic Polynomial

Let  $p : \mathbb{R} \rightarrow \mathbb{C}$  be the characteristic polynomial of the differential equation with constant coefficients

$$a_n y^{(n)} + \dots + a_1 y' + a_0 y = 0$$

and let  $p$  have the factorized form

$$p(\lambda) = a_n (\lambda - \lambda_1)^{k_1} \dots (\lambda - \lambda_m)^{k_m}$$

where  $\lambda_i \in \mathbb{C}$ ,  $m \in \mathbb{N}$ ,  $k_1, \dots, k_m \in \mathbb{N}$ ,  $k_1 + \dots + k_m = n$ .

In this case, the exponential functions

$$y = e^{\lambda_j x} \quad j \in \{1, 2, \dots, m\}$$

solve the linear differential equation.

### 5.5.5 Theorem: Complete Solution Set to LDE with Constant Coefficients

Let  $a_0, a_1, \dots, a_n \in \mathbb{R}$  be real constants, let  $m, k_1, k_2, \dots, k_m$  be (not necessarily equal) integers, let  $\lambda_1, \lambda_2, \dots, \lambda_m \in \mathbb{C}$  be complex constants and let  $p(\lambda)$  be the complex polynomial

$$p(\lambda) = a_n \lambda^n + \dots + a_1 \lambda + a_0 = a_n (\lambda - \lambda_1)^{k_1} \dots (\lambda - \lambda_m)^{k_m}$$

In this case, the family of  $n$  exponential functions

$$\mathcal{B} = \left\{ \begin{array}{l} e^{\lambda_1 x}, x e^{\lambda_1 x}, \dots, x^{k_1-1} e^{\lambda_1 x}, \\ e^{\lambda_2 x}, x e^{\lambda_2 x}, \dots, x^{k_2-1} e^{\lambda_2 x}, \\ \vdots \\ e^{\lambda_m x}, x e^{\lambda_m x}, \dots, x^{k_m-1} e^{\lambda_m x} \end{array} \right\}$$

forms a basis of the solution set to the homogeneous linear differential equation with constant coefficients

$$a_n y^{(n)} + \dots + a_1 y' + a_0 y = 0$$

and

$$k_1 + k_2 + \dots + k_m = n$$

### 5.5.6 Proposition: Real Components of a Complex Solution

If the complex function  $y : \mathbb{R} \rightarrow \mathbb{C}$  solves the homogeneous linear differential equation with constant coefficients

$$a_n y^{(n)} + \dots + a_1 y' + a_0 y = \sum_{i=0}^n a_i y^{(i)} = 0$$

then the real and imaginary components  $\operatorname{Re} y$  and  $\operatorname{Im} y$  also solve the equation.

## 5.6 LDE with Variable Coefficients

### 5.6.1 Euler-Cauchy Equation

The Euler-Cauchy equation is the linear differential equation

$$a_n x^n y^{(n)} + \dots + a_1 x y' + a_0 y = b(x)$$

where  $a_n, \dots, a_1, a_0 \in \mathbb{R}$  are real constants.

The equation is solved with the trial solution  $y = x^\lambda$ . When plugged in, the trial solution gives the polynomial equation

$$x^\lambda \sum_{i=0}^n a_i \lambda(\lambda-1) \dots (\lambda-i+1) = 0$$

## 5.7 Introduction to the Calculus of Variations

### 5.7.1 Definition: Functional

A functional is a mapping from a set of functions to the real numbers  $\mathbb{R}$ .

### 5.7.2 Functionals and Lagrangian

Let  $L : \mathbb{R}^3 \rightarrow \mathbb{R}$  be a differentiable scalar function of 3 real variables and let  $I$  be a functional mapping functions  $y$  to the real numbers  $\mathbb{R}$  with the relationship:

$$I : y \mapsto \int_a^b L(x, y, y') dx$$

The motivation of the calculus of variations is to find the function  $y : \mathbb{R} \rightarrow \mathbb{R}$  minimizing the functional  $I$ .

Typical problems involve:

- Find the shortest path connecting to points
- Find the path minimizing the time taken to travel between two points

### 5.7.3 Example: Minimizing Distance Between Points

Let  $A, B \in \mathbb{R}^2$  be two points in a plane with coordinates  $A = (a_1, a_2)$  and  $B = (b_1, b_2)$  and let  $\gamma$  be a curve connecting the points  $A, B$ . More so, let  $\gamma$  be the graph of a differentiable function  $f : \mathbb{R} \rightarrow \mathbb{R}$ .

In this case, the length  $\ell$  of the curve between  $A$  and  $B$  (i.e. the arc-length of  $\gamma$ ) is a functional of  $f$  given by:

$$\ell(f) = \int_{a_1}^{b_1} \sqrt{1 + [f'(x)]^2} dx$$

For such a problem, the Lagrangian is  $L(u, v, w) = \sqrt{1 + w^2}$  and the goal is to find the function  $f$  minimizing the functional  $\ell$ .

### 5.7.4 Example: Brachistochrone Problem

Let  $A, B \in \mathbb{R}^2$  be two points in a plane with coordinates  $A = (a_1, a_2)$  and  $B = (b_1, b_2)$  where  $b_1 > a_1$  and let  $\gamma$  be a curve connecting the points  $A, B$ . More so, let  $\gamma$  be the graph of a differentiable function  $f : \mathbb{R} \rightarrow \mathbb{R}$ .

$$s(t) = \int_{a_1}^{x(t)} \sqrt{1 + [f(\tau)]^2} d\tau$$
$$s'(t) = v(t) = \sqrt{1 + [f(x(t))]^2} (x'(t))$$

Equating potential energy

$$E_p = mgh = mg(a_2 - f(x))$$

and kinetic energy

$$E_k = \frac{mv^2}{2} = \frac{m}{2} \left( \sqrt{1 + [f(x(t))]^2} \left( \frac{dx}{dt} \right) \right)^2$$

gives

$$\sqrt{2g(a_2 - f(x))} = \sqrt{1 + [f(x)]^2} \frac{dx}{dt}$$

$$t = \int dt = \int_{a_1}^{b_1} \frac{1}{\sqrt{2g}} \sqrt{\frac{1 + [f(x)]^2}{a_2 - f(x)}} dx$$

In this case, the linear functional is  $t = t(f)$  and the Lagrangian is

$$L = L(u, v, w) = \frac{1}{\sqrt{2g}} \sqrt{\frac{1 + w^2}{a_2 - v}}$$

### 5.7.5 Formalizing the Calculus of Variation Problem

Let  $L : \mathbb{R}^3 \rightarrow \mathbb{R}$  be a scalar function of three variables, let  $I = [a, b] \in \mathbb{R}$  be an interval on the real line, let  $X$  be the space of differentiable real functions mapping from  $I$  to  $\mathbb{R}$ , and let  $y : I \rightarrow \mathbb{R}$  be a differentiable function. For a given Lagrangian  $L(u, v, w)$  we want to find the extrema of the functional

$$J(y) = \int_a^b L(x, y, y') dx$$

mapping from  $X$  to the real numbers.

The extrema of the functional  $J$  is the function  $y$  for which  $J$  has an extrema in all directions. More formally,  $y$  is the function for which for each smooth function  $\eta : I \rightarrow \mathbb{R}$  that is zero at the endpoints ( $\eta(a) = \eta(b) = 0$ ) the function  $\epsilon I \rightarrow \mathbb{R}$  mapping to  $J(y + \epsilon\eta)$  has an extrema at 0.

### 5.7.6 Critical Point of a Functional

The function  $y$  is a critical point of the functional  $J$  if  $J$  has directional derivatives

$$\left. \frac{\partial}{\partial \epsilon} J(y + \epsilon\eta) \right|_{\epsilon=0}$$

equal to zero for all smooth functions  $\eta : I \rightarrow \mathbb{R}$ .

### 5.7.7 Lemma: Integral Over a Closed Interval

Let  $I = [a, b]$  be an interval on the real line, let  $f : I \rightarrow \mathbb{R}$  be a continuous function, and let

$$\int_a^b f(x)\eta(x) dx = 0$$

for all continuously differentiable functions  $\eta : I \rightarrow \mathbb{R}$  for which  $\eta(a) = \eta(b) = 0$ . In this case,  $f(x) = 0$  for all  $x \in I$ .

### 5.7.8 Generalization of Previous Lemma

Let  $I = [a, b]$  be an interval on the real line, let  $M, N : I \rightarrow \mathbb{R}$  be continuous functions and let

$$\int_a^b (M\eta + N\eta') dx = 0$$

for all continuously differentiable functions  $\eta : I \rightarrow \mathbb{R}$  for which  $\eta(a) = \eta(b) = 0$ . In this case,  $N$  is differentiable and  $N' = M$ .

**5.7.9 Euler-Lagrange Equation**

For a Lagrangian  $L(x, y, y')$ , the Euler-Lagrange equation is

$$L_y - \frac{d}{dx} [L_{y'}] = 0$$

More formally, for a Lagrangian  $L(u, v, w)$  where  $u, v, w$  are real functions, we define the function  $V : \mathbb{R} \rightarrow \mathbb{R}^3$  with the relationship

$$V = V(x) = (x, y(x), y'(x))$$

In this case, the Euler-Lagrangian equation reads

$$\frac{\partial}{\partial v} [L(V(x))] - \frac{d}{dx} \left[ \frac{\partial}{\partial w} [L(V(x))] \right]$$

**5.7.10 Necessary Condition for Extrema of a Functional**

Let  $I = [a, b]$  be an interval on the real line, let  $y : I \rightarrow \mathbb{R}$  be a continuously differentiable function of the variable  $x$ , and let  $L : \mathbb{R}^3 \rightarrow \mathbb{R}$  with the relationship  $L = L(x, y, y')$  be the Lagrangian for the functional  $J$  defined as:

$$J(y) = \int_a^b L(x, y, y') dx$$

If  $y$  is an extrema of the functional  $J$ , then  $y$  satisfies the Euler-Lagrange equation.

**5.7.11 Note: Functional with Variable Endpoints****5.7.12 Note: Lagrangian Independent of  $y$** 

Let  $L = L(x, y')$  be a Lagrangian for a CV problem such that  $L$  is independent of  $y$ . In this case, the Euler-Lagrange equation simplifies to

$$L_{y'} = C \quad (\text{Euler-Lagrange equation if } L = L(x, y'))$$

**5.7.13 Note: Lagrangian Independent of  $x$** 

Let  $L = L(y, y')$  be a Lagrangian for a CV problem such that  $L$  is independent of  $x$ . In this case, the Euler-Lagrange equation simplifies to

$$L - y' L_{y'} = C \quad (\text{Euler-Lagrange equation if } L = L(y, y'))$$

## 6 Introduction to Hilbert Spaces and Fourier Series

### 6.1 Basics of Hilbert Spaces

For the entirety of this section, let  $V$  be a vector space over the scalar field  $\mathbb{F}$ , where in general  $\mathbb{F}$  is taken to be the complex numbers  $\mathbb{C}$ .

#### 6.1.1 Definition: Inner Product

An inner product on the vector space  $V$  is a mapping  $\langle \cdot, \cdot \rangle : V \times V \rightarrow \mathbb{R}$  mapping  $(x, y) \mapsto \langle x, y \rangle$  with the following properties:

1.  $\langle x, x \rangle \geq 0$  for all  $x \in V$
2.  $\langle x, x \rangle = 0 \iff x = 0$
3.  $\langle x, y \rangle$  is linear in the first factor and anti-linear in the second factor. In terms of the scalars  $\lambda, \mu \in \mathbb{F}$ , this is written:

$$\begin{aligned}\langle \lambda x + \mu y, z \rangle &= \lambda \langle x, z \rangle + \mu \langle y, z \rangle \\ \langle z, \lambda x + \mu y \rangle &= \bar{\lambda} \langle z, x \rangle + \bar{\mu} \langle z, y \rangle\end{aligned}$$

where  $\bar{\lambda}$  denotes the complex conjugate of  $\lambda$ .

4.  $\langle x, y \rangle = \overline{\langle y, x \rangle}$

#### 6.1.2 Definition: Inner Product Space

An inner product space is a vector space  $V$  over the scalar field  $\mathbb{F}$  equipped with an inner product  $\langle \cdot, \cdot \rangle$ .

#### 6.1.3 Definition: Norm

Let  $V$  be an inner product space and let  $x \in V$  be an element of  $V$ . A norm on the inner product space  $V$  is a mapping  $\|\cdot\| : V \rightarrow [0, \infty)$  mapping  $x \mapsto \|x\|$  with the following properties:

1.  $\|x\| \geq 0$  for all  $x \in V$
2.  $\|x\| = 0 \iff x = 0$
3.  $\|\lambda x\| = |\lambda| \|x\|$  for all  $\lambda \in \mathbb{F}$ .
4.  $\|x + y\| \leq \|x\| + \|y\|$  for all  $x, y \in V$

#### 6.1.4 Theorem: Cauchy-Schwartz Inequality

Let  $V$  be an inner product space with the norm  $\|\cdot\|$  and let  $x, y \in V$  be a elements of  $V$ . For each  $x, y \in V$ :

$$|\langle x, y \rangle| \leq \|x\| \|y\|$$

#### 6.1.5 Definition: Metric

Let  $x, y \in V$  be elements of the inner product space  $V$ . A metric on the inner product space  $V$  is the mapping  $d : V \times V \rightarrow [0, \infty)$  mapping  $(x, y) \mapsto \|x - y\|$ .

$$d(x, y) = \|x - y\|$$

**6.1.6 Definition: Completeness of a Vector Space**

A vector space  $V$  is complete if every Cauchy sequence has its limit in  $V$ .

**6.1.7 Definition: Hilbert Space**

A Hilbert space is a complete inner product space with respect to the metric induced by the inner product.

**6.1.8 Definition: The  $\|\cdot\|_1$  and  $\|\cdot\|_2$  Norms**

Let  $I = [a, b]$  be an interval on the real line and let  $f : I \rightarrow \mathbb{R}$  be an integrable function. The  $\|f\|_1$  and  $\|f\|_2$  norms are defined as

$$\|f\|_1 = \int_a^b |f| \qquad \|f\|_2 = \sqrt{\int_a^b |f|^2}$$

**6.1.9 Definition:  $L^2$  Space**

Let  $I = [a, b]$  be an interval on the real line. The Hilbert space  $L^2(I)$  is the set of all functions  $f : I \rightarrow \mathbb{C}$  for which

$$\int_a^b |f|^2 < \infty$$

where the norm is defined as

$$\|f\|_2 = \sqrt{\int_a^b |f|^2}$$

**6.1.10 Proposition: Integrating a Complex Function**

Let  $I = [a, b]$  be an interval on the real line, let  $u, v : I \rightarrow \mathbb{R}$  be real, integrable functions and let  $f : I \rightarrow \mathbb{C}$  be the complex function given by  $f = u + iv$ . In this case,  $f$  is integrable and

$$\int_a^b f = \int_a^b u + i \int_a^b v$$

**6.1.11 Comparison of the  $\|\cdot\|_1$  and  $\|\cdot\|_2$  Norms**

Let  $I = [a, b]$  be an interval on the real line and let  $f \in L^2(I)$  be a function in  $L^2(I)$ . In this case:

$$\begin{aligned} \|f\|_1 &= \int_a^b |f| = \int_a^b |f| \cdot 1 = \langle |f|, 1 \rangle \leq \| |f| \|_2 \|1\|_2 = \\ &= \sqrt{\int_a^b |f|^2} \sqrt{\int_a^b 1} = \|f\|_2 \sqrt{b-a} \end{aligned}$$

The general result is that  $\|f\|_1 \leq \|f\|_2$ , which implies that  $L^2(I) \subset L^1(I)$ .

**6.1.12 Definition: Orthogonality**

Let  $V$  be an inner product space. The elements  $x, y \in V$  are orthogonal if  $\langle x, y \rangle = 0$ .



**6.1.13 Definition: Orthogonal Complement**

Let  $V$  be an inner product space and let  $A \subset V$  be a subset of  $V$ . In this case,  $A$ 's orthogonal complement  $A^\perp$  is the subset  $A^\perp \subset V$  consisting of all  $y \in V$  for which  $\langle x, y \rangle = 0$  for all  $x \in A$ . In set builder notation:

$$A^\perp = \{y \in V \mid \langle x, y \rangle = 0 \quad \forall \quad x \in A\}$$

Note that zero is always a member of any orthogonal complement because  $\langle x, 0 \rangle \equiv 0$  for all  $x$ .

**6.1.14 Proposition: Closure of the Orthogonal Complement**

Let  $V$  be an inner product space, let  $A \subset V$  be a subset of  $V$ , and let  $A^\perp$  be  $A$ 's orthogonal complement. In this case,  $A^\perp$  is a closed set.

**6.1.15 Theorem: Pythagorean Theorem**

Let  $V$  be an inner products space and let  $x_1, x_2, \dots, x_n \in V$  be mutually orthogonal elements of  $V$ . In this case:

$$\left\| \sum_{i=1}^n x_i \right\|^2 = \sum_{i=1}^n \|x_i\|^2$$

**6.1.16 Definition: Orthogonal Projection**

Let  $V$  be an inner product space and let  $U \subset V$  be a linear subspace of  $V$ . If there exists  $u \in U$  such that, for a given  $v \in V$ , the vector difference  $v - u \perp U$ , then  $u$  is the orthogonal projections of  $v$  onto the subspace  $U$  and is denoted by  $\text{Pr}_U(v)$ .

**6.1.17 Proposition: Properties of the Orthogonal Projection**

Let  $V$  be an inner product space, let  $U \subset V$  be a linear subspace of  $V$  and define the vectors  $v \in V$  and  $u \in U$  such that  $u = \text{Pr}_U(v)$  is the orthogonal projection of  $v$  onto the subspace  $U$ .

1.  $u$  is unique.
2.  $u$  is the closest vector in  $U$  to the vector  $v \in V$ .

**6.1.18 Proposition: Calculating the Orthogonal Projection**

Let  $V$  be a finite-dimensional inner product, let  $U \subset V$  be a subspace of  $V$ , and let  $\mathcal{B} = \{e_1, e_2, \dots, e_n\}$  be an orthonormal basis of the subspace  $U$ . In this case, the orthogonal projection  $\text{Pr}_U(v)$  exists for all  $v \in V$  and is equal to

$$\text{Pr}_U(v) = \sum_{i=1}^n \langle v, e_i \rangle e_i$$

**6.1.19 Proposition: Bessel Inequality**

Let  $H$  be a Hilbert space with the orthonormal basis  $\mathcal{E} = \{e_1, e_2, \dots, e_n\}$  where  $n \in \{\mathbb{N} \cup \infty\}$  and let  $x \in H$  be an element of  $H$ . In this case,

$$\|x\|^2 \geq \sum_{i=1}^n |\langle x, e_i \rangle|^2$$

for all  $x \in H$ .

**6.1.20 Proposition: Sequences in Hilbert Spaces**

Let  $H$  be a Hilbert space with orthonormal basis  $\mathcal{E} = \{e_1, e_2, \dots\}$  and let  $(c_n)_n \in \mathbb{F}$  be a sequence in the scalars such that

$$\sum_{i=1}^n |c_i|^2 < \infty$$

In this case, the series

$$x := \sum_{i=1}^{\infty} c_i e_i$$

converges and  $c_i = \langle x, e_i \rangle$  for all  $i \in \mathbb{N}$ .

**Note: Interpreting the Previous Proposition** The sequence

$$(s_n)_n := \sum_{i=1}^n c_i e_i$$

converges in  $H$ . To confirm this, we refer to the Cauchy criterion. Let  $m, n \in \mathbb{N}$  be integers such that  $m > n$ . In this case

$$s_m - s_n = \sum_{i=n+1}^m c_i e_i$$

Next,

$$\|s_m - s_n\|^2 = \left\| \sum_{i=n+1}^m c_i e_i \right\|^2 = \sum_{i=n+1}^m |c_i|^2 < \epsilon \text{ for } m, n > M_0 \in \mathbb{N}$$

We can make the final estimate because because the  $c \in l^2$  so the partial sums  $\sum_{i=1}^n c_j$  satisfy the Cauchy criterion in  $\mathbb{F}$ .

The result is that  $(s_n)_n$  the Cauchy criterion for convergence in  $H$ . Because  $H$  is complete, there exists

$$x := \lim_{n \rightarrow \infty} s_n$$

(compare to previous proposition).

**Note: On Coefficients**

$$\lim_{n \rightarrow \infty} \langle s_n, e_i \rangle = \langle x, e_i \rangle = c_j$$

First, we show that

$$\begin{aligned} |\langle x, e_i \rangle - \langle s_n, e_i \rangle| &= |\langle x - s_n, e_i \rangle| \leq \|x - s_n\| \|e_i\| = \|x - s_n\| \\ \lim_{n \rightarrow \infty} \|x - s_n\| &= \|x - x\| = 0 \end{aligned}$$

For  $n \geq j$  we have:

$$\langle s_n, e_j \rangle = \sum_{j=1}^n c_j \langle e_j, e_i \rangle = c_j$$

The result here is that

$$\langle x, e_j \rangle = c_j$$

**Quick Review of Terms:**

$H$  is a Hilbert space with orthonormal basis  $\mathcal{E} = \{e_i\}_1^n$ .

- $c_n \in \mathbb{F}$  is a scalar and  $(c_n)_n$  is a sequence of scalars. All  $s, x$  and  $e$  terms are vectors (i.e. elements of  $H$ );  $e$  terms are orthonormal basis vectors.
- $s_n = \sum_{i=1}^n c_i e_i$  is a finite series of elements of  $H$  and an element of  $H$  itself.
- $(s_n)_n$  is a sequence of finite series i.e. a sequence of  $s_n$  terms.
- $x_n = \lim_{n \rightarrow \infty} s_n$  is a generalization of  $s_n$  to an infinite-dimensional space.

**6.2 Introduction to Fourier Series**

**6.2.1 Definition: Fourier Series**

Let  $H$  be a Hilbert space with orthonormal basis  $\mathcal{E} = \{e_i\}_1^\infty$  and define  $x \in H$ . The series

$$\sum_{i=1}^{\infty} \langle x, e_i \rangle e_i$$

is called the Fourier series of  $x$  for the chosen basis  $\mathcal{E}$  and the scalars  $\langle x, e_j \rangle \in \mathbb{F}$  are called the Fourier coefficients of the Fourier series.

**6.2.2 Definition: Completeness of a Orthonormal Basis**

Let  $H$  be a Hilbert space with orthonormal basis  $\mathcal{E} = \{e_i\}_1^\infty$  and define  $x \in H$ . The orthonormal basis  $\mathcal{E}$  is complete if

$$x = \sum_{i=1}^{\infty} \langle x, e_i \rangle e_i \quad \text{for all } x \in H$$

**6.2.3 Theorem: Equivalent Properties of Fourier Series**

Let  $H$  be a Hilbert space with orthonormal basis  $\mathcal{E} = \{e_i\}_1^\infty$ . The following properties are equivalent:

1.  $\mathcal{E}$  is a complete orthonormal basis for  $H$
2. For each  $x, y \in H$

$$\langle x, y \rangle = \sum_{i=1}^{\infty} \langle x, e_i \rangle \overline{\langle y, e_i \rangle}$$

3. Parseval's equality: for all  $x \in H$

$$\|x\|^2 = \sum_{i=1}^{\infty} |\langle x, e_i \rangle|^2$$

4.  $\mathcal{E}$  is not contained in any orthonormal system with cardinality greater than  $\mathcal{E}$ .
5. The orthogonal complement  $\mathcal{E}^\perp$  consists only of the zero vector, i.e.  $\mathcal{E}^\perp = \{0\}$ .

### 6.2.4 Note: The $L^2(-\pi, \pi)$ Space

The Hilbert space  $L^2(-\pi, \pi)$  is the space given by:

$$\{f : [-\pi, \pi] \rightarrow \mathbb{F} \mid \|f\|_2 < \infty\}$$

where the norm  $\|f\|_2$  is given by:

$$\|f\|_2 = \sqrt{\int_{-\pi}^{\pi} |f(x)|^2 dx}$$

and the inner product is

$$\langle f, g \rangle = \int_{-\pi}^{\pi} f(x) \overline{g(x)} dx \quad \forall f, g \in L^2(-\pi, \pi)$$

### 6.2.5 Proposition: Complete Orthonormal Basis of $L^2(-\pi, \pi)$

Let  $e_n : [-\pi, \pi] \rightarrow \mathbb{F}$  be the family of functions with the relation

$$e_n(x) = \frac{1}{\sqrt{2\pi}} e^{inx} \quad x \in [-\pi, \pi]; n \in \mathbb{Z}$$

and let  $\mathcal{E}$  be the set given by  $\mathcal{E} = \{e_n \mid n \in \mathbb{Z}\}$ . In this case,  $\mathcal{E}$  is a complete orthonormal basis of the Hilbert space  $L^2(-\pi, \pi)$ .

### 6.2.6 Proposition: Complete Orthonormal Basis of Real $L^2(-\pi, \pi)$

Let  $L^2_{\mathbb{R}}(-\pi, \pi)$  denote the real component of the Hilbert space  $L^2(-\pi, \pi)$ ; that is, the space given by:

$$\{f : [-\pi, \pi] \rightarrow \mathbb{R} \mid \|f\|_2 < \infty\}$$

where the norm and inner product are defined as for  $L^2(-\pi, \pi)$ . Let  $e_{n_c}, e_{n_s} : [-\pi, \pi] \rightarrow \mathbb{R}$  be the family of functions with the relation

$$e_{n_c}(x) = \frac{1}{\sqrt{\pi}} \cos(nx) \quad e_{n_s}(x) = \frac{1}{\sqrt{\pi}} \sin(nx) \quad x \in [-\pi, \pi]; n \in \mathbb{Z} \setminus \{0\}$$

and let  $\mathcal{F}$  be the set given by  $\mathcal{F} = \left\{ \frac{1}{\sqrt{2\pi}}, e_{n_c}, e_{n_s} \mid n \in \mathbb{Z} \setminus \{0\} \right\}$ . In this case,  $\mathcal{F}$  is a complete orthonormal basis of  $L^2_{\mathbb{R}}(-\pi, \pi)$ .

### 6.2.7 Proposition: Fourier Coefficients and Fourier Series

Let  $f \in L^2_{\mathbb{R}}(-\pi, \pi)$  be a function. The Fourier coefficients  $a_n, b_n \in \mathbb{R}$  for the function  $f$  with respect to the basis  $\mathcal{F}$  are given by

$$a_n = \frac{1}{\pi} \int_{-\pi}^{\pi} f(x) \cos(nx) dx \quad b_n = \frac{1}{\pi} \int_{-\pi}^{\pi} f(x) \sin(nx) dx \quad n \in \mathbb{N}$$

and Fourier series for  $f$  is

$$\frac{a_0}{2} + \sum_{n=1}^{\infty} [a_n \cos(nx) + b_n \sin(nx)] \quad \text{where} \quad a_0 = \frac{1}{\pi} \int_{-\pi}^{\pi} f(x) dx$$

Note that in general the Fourier coefficients, and thus the Fourier series, for a given function  $f \in L^2_{\mathbb{R}}(-\pi, \pi)$  depend on the choice of the basis for the space  $L^2_{\mathbb{R}}(-\pi, \pi)$ .

**6.2.8 Proposition: Fourier Coefficients Fall with Increasing  $n$** 

Let  $f \in L^2(-\pi, \pi)$  be a function with Fourier coefficients  $a_n, b_n$  and define  $x \in [-\pi, \pi]$ . In this case

$$\lim_{n \rightarrow \infty} \int_{-\pi}^{\pi} f(x) \cos(nx) dx = \lim_{n \rightarrow \infty} \int_{-\pi}^{\pi} f(x) \sin(nx) dx = 0$$

In other words:

$$\lim_{n \rightarrow \infty} a_n = \lim_{n \rightarrow \infty} b_n = 0$$

**6.2.9 Definition:  $L_2$  Convergence of Fourier Series**

Let  $f \in L^2_{\mathbb{R}}(-\pi, \pi)$  be a function and let  $s_n(x)$  be the sequence given by

$$s_n(x) = \frac{a_0}{2} + \sum_{k=1}^n [a_k \cos(kx) + b_k \sin(kx)]$$

The sequence  $s_n$  converges to  $f$  in the  $L_2$  sense if

$$\lim_{n \rightarrow \infty} \|s_n - f\|_2 = 0$$

**6.2.10 Proposition:  $L_2$  Convergence of Fourier Series**

Let  $f \in L^2_{\mathbb{R}}(-\pi, \pi)$  be a function and let  $s_n(x)$  be defined as above. In this case,  $s_n$  converges to  $f$  with respect to the  $L_2$  norm (i.e. in the  $L_2$  sense described above) for all  $f \in L^2_{\mathbb{R}}(-\pi, \pi)$ .

**6.2.11 Proposition: Identity for Fourier Coefficients**

Let  $f \in L^2_{\mathbb{R}}(-\pi, \pi)$  be a function with Fourier coefficients  $a_0, a_n, b_n$ . In this case

$$\frac{1}{\pi} \int_{-\pi}^{\pi} |f(x)|^2 dx = \frac{a_0^2}{2} + \sum_{n=1}^{\infty} (a_n^2 + b_n^2)$$

for all  $x \in [-\pi, \pi]$ .

**6.2.12 Definition: Pointwise Convergence of Fourier Series**

Let  $f \in L^2_{\mathbb{R}}(-\pi, \pi)$  be a function and let  $s_n(x)$  be the sequence given by

$$s_n(x) = \frac{a_0}{2} + \sum_{k=1}^n [a_k \cos(kx) + b_k \sin(kx)]$$

The sequence  $s_n$  converges pointwise to  $f$  if

$$\lim_{n \rightarrow \infty} s_n(x) = f(x) \quad \forall \quad x \in [-\pi, \pi]$$

Pointwise convergence is in general a stronger requirement than convergence in the  $L_2$  sense. Unlike for  $L_2$  convergence, the sequence  $s_n$  *does not* converge pointwise to  $f$  for all  $f \in L^2_{\mathbb{R}}(-\pi, \pi)$  but only for special cases of  $f$ .

**6.2.13 Theorem: Pointwise Convergence of Fourier Series for Continuous Functions**

Let  $f \in L^2(-\pi, \pi)$  be a continuous and differentiable function with Fourier coefficients  $a_0, a_n, b_n$ . In this case,  $f$ 's Fourier series converges pointwise to  $f$  for all  $x \in [-\pi, \pi]$ . In other words:

$$f(x) = \frac{a_0}{2} + \sum_{n=1}^{\infty} [a_n \cos(nx) + b_n \sin(nx)]$$

**6.2.14 Theorem: Pointwise Convergence of Fourier Series for Piecewise Continuous Functions**

Let  $f \in L^2(-\pi, \pi)$  be a piecewise continuous and piecewise differentiable function with Fourier coefficients  $a_0, a_n, b_n$ . More so, let  $f_-(x)$  and  $f_+(x)$  denote the left and right limits, respectively of  $f$  at  $x$ , written in symbols as:

$$f_-(x) = \lim_{t \rightarrow x^-} f(t) \qquad f_+(x) = \lim_{t \rightarrow x^+} f(t)$$

In this case,  $f$ 's Fourier series converges pointwise to  $f$  for all  $x \in [-\pi, \pi]$ . In other words:

$$\frac{f_-(x) + f_+(x)}{2} = \frac{a_0}{2} + \sum_{n=1}^{\infty} [a_n \cos(nx) + b_n \sin(nx)]$$
